Terms & Conditions:

1. Two bid system should be followed for submitting the offer. Uploading of required document shall be done on MSETCL's SRM E-Tender website http://srmetender.mahatransco.in. All eligible supplier/ contractors are mandated to get enrolled on SRM E tender (new) portal of MSETCL The RFx. complete in all respect should be submitted between the period from 10.08.2018, 19:00 Hrs to 25.08.2018, 23:59 Hrs.positively.

A. <u>Techno-commercial bid:</u> This should contain following documents, certificates (all self attested copies) as a proof of qualifying pre-requisites, broachers, attested certificates etc.

1	Full name of quotation submitting firm & full address of the same.				
2	Contractors name, permanent address & Address Proof.				
3	Valid shop act & establishment registration/grampanchayat NOC as applicable.				
4	Full name of quotation submitting firm, Bank name, bank address, bank account details, PAN No. Should be submitted.				
5	GST Registration Certificate. If not applicable then undertaking regarding that.				
6	The experience certificate of Similar work shall be obtained along with Work Order Copy from the authority of the rank of or above Executive Engineer or equivalent shall be submitted.				

Failing to submission of above said documents will lead to reject the offer

If validity of any license / certificate expires during order period, you will have to renew the same and submit the copy to this office. Payment will be effected for valid period only.

- **B.** Price bid: Bidder should upload the digitally signed price bid under commercial bid online.
- a. Techno commercial bid will be opened <u>online</u> for all received bids. After verifying the set of documents / certificates submitted in Techno commercial bid for prequalification as mentioned above, if it is found that, the bidder fulfills the desired prerequisites; the price bid will be opened <u>online</u>.

If the same is not found to be meeting the prerequisites, the Price bid shall not be opened.

- b. This office reserves all the rights to reject any or all bids without assigning any reasons thereof.
- c. The offer shall be valid up to 120 days from the date of opening of the quotation/bid
- 2. Place of work 220KV Dondaicha and 220KV Shahada S/S.
- 3. Quote material price including freight, insurance, transporation etc.
- 4. "The estimated rates given by this office are inclusive of taxes. However, the bidder should quote rates exclusive of all Taxes. The taxes should be quoted separately."
- **5.** The contractors will have to bear GST applicable from time to time by the Government.
- 6. SECURITY DEPOSIT: The Tenderer will have to pay security deposit within 15 days from the date of receipt of the work order, amounting to 5 % of the value of the contract in form of Cash//D.D. only of any Nationalized/ scheduled Bank in the name of Executive Engineer, EHV O&M Division, MSETCL, Dhule. The security deposit will be refunded only after satisfactory completion of Guarantee Period.

7. AGREEMENT AND STAMP-DUTY:

- I. The successful bidder has to execute an Agreement with The Executive Engineer, EHV O&M Division, MSETCL, Dhule within 15 days after receipt of order.
- II. The successful bidder shall submit an Agreement Bond on non-judicial stamp paper of **Rs. 500** as per the Clause 63 of Mumbai Stamp Duty Act 1958. The expenses towards the stamp paper and preparation of Agreement Bond will be on the part of the contractor.

8. SCOPE OF WORK:

Work of Conversion of Double Tier wooden battery stands into Single Tier battery stands (supplying new battery stand) at 220KV Dondaicha and Shahada S/S.

The contractor should dismantle the existing Two Tier Stand and supply with erection the required Single tier New Battery stand with guarantee for one year of materials and services upto successful commission of Battery Set. The size of the Battery stand should be as per the guideline and instruction from Executive Engineer, EHV O&M Div.Dhule. Also The battery stand should be coated and painted as per instructions. i.e. by antiacid black butiminous paint.

The responsibility of the insurance towards the same shall be with the contractor. The compensation to the contractor's personnel will be the responsibility of the contractor.

9. Guarantee of Material & Services:

The material & services should be guaranteed for the period of one year from dt. of completion of work. No charges will be paid for the services during the guarantee period.

10. VARIATION IN DESIGN AND VARIATION IN QUANTITIES OF WORK:

The work will be generally carried out in accordance with the drawing and particular specifications and instructions given at site. The Ex. Engineer reserves the right to make any changes in drawing at the places of the work and the contractor is bound to carry out them. The Ex. Engineer also reserves right to increase or decrease the quantities of work to be executed or deleted or add any items, part or whole thereof.

11. SUITABILITY OF TECHNICAL AND SKILLED PERSONNEL:

The contractor shall keep one full time experienced technical responsible person at site, he shall be fully authorized to receive and comply with such instructions as are given by the Engineer-in-charge. The name of such person with his qualification and experience shall also be immediately reported to the Engineer-in-charge. The contractor must also provide for necessary skilled and unskilled workmen for each class of work and the Engineer-in-charge have the right to satisfy himself about the suitability or otherwise of such workmen.

12. WORK COMPLETION PERIOD: - The total work completion period is 60 days for both 220KV Dondaicha and 220KV Shahada S/S. Work should be completed in stipulated outage period given by sub-station incharge from the date of handing over the site subject to availability of outage for a particular job.

- 13. **QUANTITIES:** The quantities indicated in the schedule 'A'. The payment will be done for the actual quantity of work done.
- <u>14.</u> **EXECUTION OF WORKS:** Tenderer will have to execute the works in presence of respective Executive Engineer / Concerned Substation incharge & your representative.
- 15. The Contractor shall have to arrange for the transport of materials, Man power, equipments and T&Ps include all such cost in the rates quoted by him for finished work.
- <u>16.</u> **ACCIDENT :-** If any accident occurs to the labour skilled or unskilled, compensation if any, is to be paid by the agency at his cost.
- <u>17.</u> **APPLICABILITY OF GENERAL CONDITIONS OF CONTRACT:** -Notwithstanding anything stated here, the MSETCL's General Terms & Conditions of Contract shall be applicable to the contract as far as they are applicable to your contract.
- <u>18.</u> **TERMINATIONS OF CONTRACT :-**The undersigned reserves the right to cancel the contract, after giving due notice to you, in the event of the breach of contract in any respect or undue delay in execution of works /starting of the works.
- 19. If you fail to execute the work, it will be treated as breach of contract & contract will be terminated and order will be cancelled by forfeiting the security deposit.
- <u>20.</u> Since the Sub-Station area is declared as prohibited area by the Government, it is necessary to give the name of workers to the Work-in-Charge and the same should be got approved by him. The Work-In-Charge is fully empowered for giving or refusing the permission for entrance in the substation area in exigencies.
- <u>21.</u> Liquidated Damages / Loss due to theft: Any damage or loss to M. S. E T. Co. Ltd's property due to your employees' negligence during the course of contract shall be on contractor's part and same shall be recovered from the bill.
- <u>22.</u> Work should be carried out as per the directives of Executive Engineer, EHV O&M Div.Dhule or its representatives i.e. incharge of 220KV Dondaicha and Shahada Sub-stations.
- 23. Agency should submit **GST** Registration and other relevant registrations.
- <u>24.</u> The M. S. E. T. Co. Ltd. shall not be responsible for injury or death of your employee during the course of contract. Contractor will have to provide safety equipments to his employees.
- <u>25.</u> Contractor will be solely responsible for compensation or medical treatment etc. for all the liabilities arising out of such accident. It shall be the sole responsibility of the contractor to observe all the relevant acts and regulations along with amendments thereto framed by the Government from time to time. The MSETCL shall not be responsible for violation of any of the above stated regulations / Acts etc. by the contractor.
- <u>26.</u> Instructions given by sub-station incharge regarding work in Live Switchyard should be strictly followed by Contactor.
- <u>27.</u> **If any type accident occurs, whole responsibility shall be of Contractor. MSETCL** shall not be responsible for that.
- 28. The disputes, if any, shall be subjected to the jurisdiction of the **Dhule** Court only.
- <u>29.</u> The undersigned reserves the right to cancel the SRM E-enquiry at any stage or cancel any or all quotations without assigning any reason thereof.
