Please offer your reasonable rates in % percentage only for Enquiry for up-gradation of Desktop Computers by new ones at MSETCL EHV O&M Dn. Ratnagiri.

**Terms and Conditions:**

- 1) Due Date: The quotations complete in all respects, dully sealed & super scribed should be submitted to this office on or upto **21.08.2018**, 17:30 Hrs.
- 2) Documents required: PAN/ TAN registration certificate, Valid GST registration certificate & Proof of firm being registered as shop establishment/firm/ Company as applicable.
- 3) Supply of Material: Materials offered should be strictly as per specification mentioned in Schedule 'A' & sample approved. The material shall be subject to approval of consignee after testing.
- 4) The quotations will be evaluated on the basis of specification/brand/make of the product as per MSETCL requirement. If considered necessary, the MSETCL committee may take the decision in this regards and decision of Committee would be final and binding to bidder.
- 5) Delivery Period: The material should be delivered to the consignee within 30 days from the date of issue of order.
- 6) Destination For Supply: The material should be supplied at EHV O&M Division, Ratnagiri during working hours 10:00 Hrs. to 17:00 Hrs. on working day.
- 7) Your representative shall also deliver following document: i) Final invoice in triplicate. ii) Delivery Challan iii) Work Completion report.
- 8) Acceptance of Quotation: The Company does not bind to accept the lowest or any quotations neither will any reasons be assigned for rejection of any enquiry. It is also not binding on the company to disclose any analysis report of enquiry.
- 9) Security Deposit: The contractor should pay security deposit at the rate of 5% of the value within 7 days from the date of receipt of LOI, in the office of the Superintending Engineer EHV O&M Circle Kolhapur in form of cash/ DD of Nationalized Bank or Schedule Bank which will be refunded after completion of work successfully or completion of guarantee period.
- 10) Terms of payments: 100% payment will be affected to you within 45 days after supply, installation, testing and commissioning of all material & on the basis of actual measurement recorded by the engineer-in-charge. However release of payment may depend on availability of funds.

- 11) Penalty for late delivery: If the materials are not supplied within stipulated time limit, penalty at the rate 1/2% (Half Percent) per week delay will be recovered from your bill subject to 10% maximum of work order value. In case failing of supply goods from your side, the balance goods will be purchased from other agency & difference in cost will be recovered from your bill & SD in this case will be forfeited to company.
- 12) Penalty for downtime: Agency/Company should solve the problem within two working days from the time of issue reported. If this downtime exceeds more than two working days then Rs. 100/- per day will be charged as penalty, subject to 10% maximum of work order value.
- 13) Quantity: Material should be supplied as per specifications and quantity mentioned in enclosed Schedule 'A' only & quality as per sample approved.
- 14) If the materials are not approved/ received in good condition, the same shall have to be replaced in part or in whole as per case.
- 15) Warranty: One year warranty from the date of commissioning of the PC Spares. During the warranty period you will replace/ repair free of cost if material found defective in coordination with OEM.
- 16) Agency/ Company should submit the warranty certificate.
- 17) The warranty would be on-site and comprehensive in nature and back to back support from the OEM. The vendor will warrant all the hardware and software for OEM warranty period from the date of acceptance of the hardware.
- 18) The work should be done as per the specifications given in the Schedule 'A' and as per the scope of work. MSETCL will not accept the items with different specifications.
- 19) If any dispute arises, the decision of the undersigned is final and binding on you.
- 20) Partial supply/installation/configuration/commissioning will not be accepted by the MSETCL. No any payment will be made for partially executed work.
- 21) Support Period: You will provide onsite services for any technical problem in the executed work for the period of **One Year**.
- 22) Transit Insurance: Any damage during transit will not be the responsibility of MSETCL and bidder must agree to provide a replacement at his cost. Transit Insurance will be borne by bidder.
- 23) Packing: The material shall be packed suitably for Rail/Road worthy packing as per standard practice.
- 24) Income Tax & W.C.T. will be deducted from your bills as per rules.
- 25) No extra charges for transportation, T&P, labour, packing, insurance, excise, material etc. will be paid, it will be arranged by you only.
- 26) Quality of work and Material: Bidder will be responsible for quality of work and workmanship. The material should be supplied as per specification. Sample should be approved from committee formed & Executive Engineer EHV O&M Dn., Ratnagiri on dt. **18.08.2018 at 10 AM**.
- 27) Accident: If any accident occurs to your labour skilled or unskilled, compensation if any, is to be paid by bidder only.
- 28) Consignee for supply: The consignee are as below or his authorized representative.

- 29) For any loss to the company's property during execution of work, the bidder will be liable to pay the equivalent compensation as per the recommendation of concerned Engineer.
- 30) MSETCL will not be responsible for any accident (fatal or non-fatal) or injury to the personnel of the agency or any financial implication arising there from.

- 31) Apart from the above points, all the terms and conditions published by MSETCL in booklet "Tender & Contract of Works" are applicable here also.
- 32) All the terms and conditions for the supply, testing and acceptance, payment terms, penalty etc. shall be as those mentioned herein and no change in the terms & conditions will be acceptable.
- 33) The enquiry should be completed with all particulars. Wherever, it is mentioned the enquiry must be signed along with seal. Any document of the enquiry not bearing the signature of bidder is liable to be rejected.
- 34) Right to reject any or all quotations is reserved by the undersigned.
- 35) This office does not bind itself to accept the lowest or any bid and reserves the right to reject all or any bid or cancel the Enquiry without assigning any reason whatsoever. - 39) No increase, decrease, discount reduction or any other changes in the price will be acceptable after the opening of the quotation.
- 40) The rates quoted should be valid for 120 days from the date of opening of quotation.
- 41) In case of dispute, if any, the legal jurisdiction of the court shall be Ratnagiri only.

The MSETCL will not be liable to pay nor shall you be entitled to claim any bill amount due or payable under the contract until the agreement is executed with MSETCL. The necessary Stamp Duty for the agreement shall be borne by you.
- 44) GST need to be specified clearly on quotation.

**Scope of Work**

MSETCL is looking to select the Company/ Agency for the works of Up-gradation of existing PC. Scope of this work includes but not limited to following works,

1. Up-gradation of existing PC as per the terms & conditions, Schedule 'A' and scope of work as per Annexure 'A'.
2. Agency/ Company should transfer the data from old PC to new PC.
3. Agency/Company should install and configure all existing applications/software available on old PC to new PC including Microsoft Office/Outlook/Scada application/Operation Section application etc.
4. Equipment furnished shall be complete in every respect with all mountings, fittings fixtures and standard accessories normally provided with such equipment's and/or needed for erection, completion and safe operation of the equipment's as required by applicable codes though they may not have been specifically detailed in the enquiry document, unless included in the list of exclusions. All similar standard components/parts of similar standard equipment's provided shall be interchangeable with one another.
5. The Bidder shall be responsible for providing all materials, equipment's, and services specified or otherwise, which are required to fulfill the intent of ensuring operability, maintainability, and reliability of the complete equipment covered under this specification within his quoted price. This work shall be in compliance with all applicable standards, statutory regulations and safety requirements in force of the date of award of this contract.
6. The bidder shall also be responsible for deputing qualified personnel for installation, testing, commissioning and other services under his scope of work. All required tools and tackles for completing the scope of work as per the specification is also the responsibility of the bidder.
7. Material should be supplied in a ready to use condition along with all cables, Connectors, Software drivers, Manuals and Media etc.
8. The agency/company should integrate the hardware with the existing LAN\WAN infrastructure. UTP CAT 6 patch cord (3 meter) should be supplied along with each PC.
9. The installation of equipment shall be accepted only after installation tests are over.
10. Onsite warranty for all installation and material delivered for minimum one year and extended as per OEM guarantee/warranty offered.
11. Onsite Technical Support/maintenance for the period of ONE YEAR from the date of installation accepted by the MSETCL.
12. The offered material shall be of good quality, reputed brand and approved by the competent authority.
