**Sub.:-** Hiring of poclain for transportation of steel, liner and pile foundation related work at Location No. 3 (S + 15 Mtr) of 132 KV Dahanu – Gholwad Line (Crossing No. 7) for new TSS of western Railway at Gholwad , under EHV Projects Dn. Kalyan for M/s DFCCIL under ORC under EHV Projects Dn, Kalyan.

Sealed and super scribed quotations are invited for the work of “Hiring of Poclain for transportation of steel, liner and pile foundation related work at Location No. 3 (S + 15 Mtr) of 132 KV Dahanu – Gholwad Line (Crossing No. 7) for new TSS of western Railway at Gholwad” , under EHV Projects Dn. Kalyan for M/s DFCCIL under ORC as per Annexure “A”. The quotation should reach this office on or before **29.08.2018 at 13.00 Hrs.**

**Nature of work :**

The proposed location No. 3 is nearer to bank of creek and requires pile foundation work. Location No. 3 lies in the water logging area of creek. Due to continuous & heavy rain fall the approach road for the said loc. No. 3 is lies in marshy land and this land has become swampy. The job will be to transport all material required for foundation & erection of tower at Loc. No 3 up to desired location in creek from the existing approach road. The Poclain should carry out all the required excavation work at Loc. No. 3. Tentative time period for above said work will be 1 month

**Terms & Conditions**

- 1) Scope of work:-Transportation of all required material with poclain in the water logging area and marshy land at Loc. No 3 of the above said line at Gholwad in Boisar area for foundation & erection work of tower from the existing approach road. Poclain should be capable of carrying all heavy material/equipment's required for pile foundation & tower erection work. The contractor must provide backup in case of failure of poclain and other allied equipment if any due to which work should not get hampered.
- 2) The Estimated value of this contract as per schedule “A” shall be **Rs. 2,98,200/-** (Rs.Two Lakhs Ninety Eight Thousand Two Hundred only) including G.S.T. @18%, all taxes.
- 3) Security deposit: - The successful contractor will have to pay Security deposit amount 5% of the total value of order by cash or by demand draft to this office.

- 4) Contractor shall furnish EMD amount is Rs.3,000/- in the form of cash along with the quotation and write M. R. No. over the sealed cover of quotation.
- 5) **Agreement:** - An agreement on stamp paper (Rs.500/-) should be made as per procedure and cost will be bear by Agency.
- 6) Price Escalation Clause shall not be applicable for this work.

**Experience Criteria:-**

Bidder should have sufficient experience of execution of such work and eligibility will be decided accordingly by Executive Engineer, EHV Projects Dn, Kalyan on your submitted experience.

**Technical Criteria:-**

- I] Requirement of statutory registration.
  - 1.1 The bidder should have valid proof for GST registration certificate.
  - 1.2 The Bidder should provide proof of registration of firm under Bombay shop & Establishment act.
  - 1.3 The bidder should have valid Transport contractor's license OR valid Electrical contractor's License.

**Financial criteria:-**

- I] Average annual financial turnover during the last 3 financial years ending 31st March of the previous financial year should be at least 60% of the estimated cost.
- II] The bidder should have income Tax returns of last three financial years with PAN card copy.
- III] Proof of EMD payment with MR no.
- IV] Net –worth :- The average net-worth (calculated as per the definition of net worth ) of the bidder for the previous 3 financial year ,duly certified by C.A., should not be less than 25% of the estimated cost.

As per the circular published by corporate office in r/o exemption of EMD for SSI&NSIC unit, it is to indicate the following condition in field tender as follows:-

Following cases:-


- I) If S.S.I./N.S.I.C. certificate do not indicate material/services required against present tender.
- II) If turnover or manufacturing capacity exceeds the limit indicated the limit indicates in S.S. I/N.S.I.C. certificate specified by the concerned authority to avail the benefit of E.M.D. exemption.  
If required E.M.D. is not paid by the bidder, the offer is liable for rejection.”
- V] Labour insurance against workmen compensation act for the labour required for the works.
- 7) Time limit allowed for the completion of above work is 1Month from the handing over of site/ issue of work order.



- 8) The undersigned reserves the right to reject any or all the quotation without assigning any reasons thereof. Any term and conditions found necessary at a later stage will be quoted Separately.
- 9) Bill: - The bill in triplicate is to be submitted through Concern Sub divisions & payment will be made subject to the submission of bills with required documents from you. The payment will be released by this office, after receipt of bill duly audited and certified by the Executive Engineer E.H.V. Project Division, Kalyan depending on the fund position in reasonable period. Whenever there is paucity of funds, the priority of payments of bill of various agencies will be decided by the undersigned and all the rights in this regards are reserved with the undersigned and binding upon you. The contractor is not entitled to claim any interest / compensation due to delay in their payments of bills on account of paucity of funds. No claim for payment of interest / damages etc. for any delay in the payment shall be considered or payable by the M.S.E.T.C.L.
- 10) The work should be carried out as per standard and to the satisfaction of the Engineer-In-charge.
- 11) All tools & plants required for the work shall be arranged by contractor at his own cost.
- 12) Contractor will have to make goods damages if any, made by him to the MSETCL property during the transportation of Material at his cost otherwise the same will be recovered from the contractor by MSETCL.
- 12) The work shall be supervised by Addl Ex. Engr., EHV Substation Projects S/Dn., Kalyan. The contractor should obtain a certificate from related concern Sub divisions for having execution of work satisfactorily.
- 13) The quoted rates should be firm and should include all such as duties, all type of taxes, toll etc. Also mention the SAP vendor number on quotation.
- 14) The undersigned reserves the right to reject any or all the quotation without assigning any reasons thereof.
- 15) Any term and conditions found necessary at a later stage will be quoted separately.


