
With reference to the above sealed and super scribed quotations are invited by the undersigned for the **Work of supply of tripping relays at various substation under EHV(O&M) Division, Nanded** from 10.10.2018 so as reach this office on or before Dt. 20.10.2018. The Terms and conditions are as given below.

TERMS AND CONDITIONS:-

- 1) Please refer the schedule attached herewith and quote your offer for the same.
- 2) The rates should be quoted by you in Schedule. No Price variation is applicable. GST rate as applicable will have to be quoted separately in space provided. If nothing is specified by you, the quoted rates will be considered as inclusive of all taxes.
- 3) **Documents required:** - the rate offer must be accompanied with the following documents duly attested & signed by the vendor.
 - a. Valid Goods & Service Tax (GST) registration certificate alongwith PAN.
 - b. Valid Shop Act / MSME/ NSIC Registration.
 - c. Work experience certificate of similar work executed (not below the rank of Executive Engineer)
- 4) The work should be carried out strictly within 60 days from the date of issue of work order.
- 5) **Penalty:-** If you fail to execute the work within stipulated time as mentioned above, you will be liable to pay penalty at the rate of ½% per delayed day, subject to a maximum limit of 10% of the total value of the order.
- 6) **Quality:-** Material should be supplied strictly as per the specification mentioned in schedule otherwise same will be rejected.
- 7) **GUARANTEE:** The Relays supplied by you shall be guaranteed for period of 12 months from the date of commissioning of relay.
- 8) **GENERAL:-** You should make yourself fully aware of M.S.E.T.Co.Ltd.'s general condition of contract for supply of material as it will be applicable for this contract.

- 9) AGREEMENT;-** You will have to execute the agreement bond with Executive Engineer, EHV O & M Division Nanded on stamp paper of 500/-.The cost of stamp paper will be borne by you.
- 10) DELIVERY:-** The time being essence of the contract, the supplier should strictly adhere to the delivery period as per schedule 'A'. The delivery will be deemed to have been completed on the date of R.R. / on the date of receipt of material at major stores, Osmanabad. A postal transit period of 7 days will be allowed from the date of issue of order.
- 11) PAYMENT:-** Suppliers will be paid 100% payment of the contract price along with 100% taxes as applicable of each consignment by A./c. payee cheques OR by NEFT/RTGS (in case of such request from agency) against delivery. The bill should be submitted to this office in triplicate, accompanied by the S.R. Note of Consignee, test certificates (if any), and advance stamp receipt.
- 12) SECURITY DEPOSIT:** You have to pay security deposit within 7 days from the date of receipt of the work order, amounting to 5% of the value of the contract in the form of Cash/FDR/D.D./BG of any Nationalized/ scheduled Bank in the name of EE, EHV O&M Division, Nanded payable at Nanded valid for one year.
- 13) Deductions :-** Income Tax, Labour cess & statutory taxes as applicable shall be deducted from your bills as per prevailing Government rules.
- 14) Sample Approval :-** Sample of Tripping relay as per applicable standard & specification should be approved by the Executive Engineer EHV(O&M) Division, Nanded OR his nominated representative not below the rank of Additional Executive Engineer before delivery.
- 15) VALIDITY OF ORDER:** The order will be valid for until exhausting of the order amount OR for a period of three months from the date of issue of work order whichever is earlier.
- 16) TERMINATION OF CONTRACT:** The Undersigned reserve the right to terminate the contract at any stage without assigning any reasons thereof.
- 17) JURISDICTION:** All disputes or difference arising out of and in connection with the contract shall be subject to the exclusive jurisdiction of Nanded Court only.
