All eligible supplier/ contractors are mandated to get enrolled on SRM E tender (new) portal of MSETCL The RFx. complete in all respect should be submitted between the period from 09.10.2018, 18:00 Hrs to 23.10.2018, 23:59 Hrs. positively.

A. <u>Techno-commercial bid:</u> This should contain following documents, certificates (all self attested copies) as a proof of qualifying pre-requisites, broachers, attested certificates etc.

1	Full name of quotation submitting firm & full address of the same.			
2	Contractors name, permanent address & Address Proof.			
3	Valid shop act & establishment registration/grampanchayat NOC as applicable.			
4	Bank name, bank address, bank account details, PAN No. Should be submitted.

6	Valid Electrical Contractor license.			
7	The experience certificate of Similar work in MSETCL or MSEDCL shall be obtained along with Work Order Copy from the authority of the rank of or above Executive Engineer or equivalent shall be submitted.			

#### Failing to submission of above said documents will lead to reject the offer If validity of any license / certificate expires during order period, you will have to renew the same and submit the copy to this office. Payment will be effected for valid period only.

B. <u>Price bid</u>: Bidder should upload the digitally signed price bid under commercial bid online.

a. Techno - commercial bid will be opened <u>online</u> for all received bids. After verifying the set of documents / certificates submitted in Techno - commercial bid for prequalification as mentioned above, if it is found that, the bidder fulfills the desired prerequisites; the price bid will be opened <u>online</u>.

If the same is not found to be meeting the prerequisites, the Price bid shall not be opened.

- b. This office reserves all the rights to reject any or all bids without assigning any reasons thereof.
- c. The offer shall be valid up to 120 days from the date of opening of the quotation/bid
- **<u>2.</u>** Place of work Any sub-station under EHV O&M Division Dhule.
- 3. <u>Quote price including all taxes and charges except GST. GST should be mention</u> <u>separately.</u>
- 4. <u>"The estimated rates given by this office are inclusive of taxes. However, the bidder should quote rates exclusive GST. The taxes should be quoted separately."</u>
- **<u>5.</u>** The contractors will have to bear GST applicable from time to time by the Government.
- <u>6.</u> SECURITY DEPOSIT :- The Tenderer will have to pay security deposit within 15 days from the date of receipt of the work order, amounting to 5 % of the value of the contract in form of Cash//D.D. only of any Nationalized/ scheduled Bank in the name of Executive Engineer, EHV O&M Division, MSETCL, Dhule. The security deposit will be refunded only after satisfactory completion of Guarantee Period.

# **<u>7.</u>** AGREEMENT AND STAMP-DUTY:

I. The successful bidder has to execute an Agreement with The Executive Engineer, EHV O&M Division, MSETCL, Dhule within 15 days after receipt of order.

II. The successful bidder shall submit an Agreement Bond on non-judicial stamp paper of **Rs. 500** as per the Clause 63 of Mumbai Stamp Duty Act 1958. The expenses towards the stamp paper and preparation of Agreement Bond will be on the part of the contractor.

# **<u>8.</u>** SCOPE OF WORK:

# The work of providing & fixing of cable jointing kits of HT cables at various EHV S/ss under EHV(O&M) Division, Dhule as & where required basis. <u>Work is Emergency nature and service</u> <u>must be given before time limit.</u>

The material shall be delivered directly at site safely The material shall be used with prior inspection at site by concerned Engineer incharge. Material used shall be as per MSETCL standard.

# 9. Guarantee of Material & Services:

The material & services should be guaranteed for the period of one year from dt. of completion of work. No charges will be paid for the services and material during the guarantee period.

10. SUITABILITY OF TECHNICAL AND SKILLED PERSONNEL:

The contractor shall keep experienced technical responsible persons at site, he shall be fully authorized to receive and comply with such instructions as are given by the Engineer-in-charge. The name of such person with his qualification and experience shall also be immediately reported to the Engineer-in-charge. The contractor must also provide for necessary skilled and unskilled workmen and the Engineer-in-charge have the right to satisfy himself about the suitability or otherwise of such workmen.

# **<u>11.</u>** WORK COMPLETION PERIOD: -

Works shall be completed within 02 Days from the date of Intimation of work by concern S/Stn In charge under the supervision of him.

<u>12.</u> **ACCIDENT :-** If any accident occurs to the labour skilled or unskilled, compensation if any, is to be paid by the agency at his cost.

<u>13.</u> **APPLICABILITY OF GENERAL CONDITIONS OF CONTRACT:** -Notwithstanding anything stated here, the MSETCL's General Terms & Conditions of Contract shall be applicable to the contract as far as they are applicable to your contract.

<u>14.</u> **TERMINATIONS OF CONTRACT :-**The undersigned reserves the right to cancel the contract, after giving due notice to you, in the event of the breach of contract in any respect or undue delay in execution of works /starting of the works.

**<u>15.</u>** If you fail to execute the work, it will be treated as breach of contract & contract will be terminated and order will be cancelled by forfeiting the security deposit.

<u>16.</u> Since the Sub-Station area is declared as prohibited area by the Government, it is necessary to give the name of workers to the Work-in-Charge and the same should be got approved by him. The Work-In-Charge is fully empowered for giving or refusing the permission for entrance in the sub-station area in exigencies.

<u>17.</u> Liquidated Damages / Loss due to theft: - Any damage or loss to M. S. E T. Co. Ltd's property due to your employees' negligence during the course of contract shall be on contractor's part and same shall be recovered from the bill.

<u>18.</u> The M. S. E. T. Co. Ltd. shall not be responsible for injury or death of your employee during the course of contract. Contractor will have to provide safety equipments to his employees.

<u>19.</u> Contractor will be solely responsible for compensation or medical treatment etc. for all

the liabilities arising out of such accident. It shall be the sole responsibility of the contractor to observe all the relevant acts and regulations along with amendments thereto framed by the Government from time to time. The MSETCL shall not be responsible for violation of any of the above stated regulations / Acts etc. by the contractor.

<u>20.</u> Instructions given by sub-station incharge regarding work in Live Switchyard should be strictly followed by Contactor.

- 21. If any type accident occurs, whole responsibility shall be of Contractor. MSETCL shall not be responsible for that.
- 22. The disputes, if any, shall be subjected to the jurisdiction of the **Dhule** Court only.
- 23. The undersigned reserves the right to cancel the SRM E-enquiry at any stage or cancel any or all quotations without assigning any reason thereof.
