TERMS AND CONDITIONS :-

1. **SCOPE OF WORK** – Scope of work covers activities mentioned in SCHEDULE 'A'.
2. **VALUE OF ORDER** – The total value of order is Rs. 2,00,000/- (Rs. Two Lakh only). The work will be carried out as per the instructions of The Executive Engineer, 400 kV RS Dn, Thaptitanda and supervised by The Additional Executive Engineer, 400 kV Maintenance Unit, Thaptitanda.
3. **EXECUTION OF WORK** - You will have to execute the work in presence of concerned In-charge or his representative in 400 kV RS Dn., Thaptitanda.
4. Price should be quoted in figures as well as in words without any overwriting.
5. Name and address of vendor and recipients should be introduced on envelop.
6. **PRECAUTIONS** – All equipments in 400 kV, 200 kV switchyards at 400kV Thaptitanda sub-station are in electrically-charged condition. The liability of taking safety precautions and providing safety equipments lies to you only at your own cost.
7. **Submission of Documents:-** You are required to submit the following necessary documents along with the quotation:
 - a) **GST**-registration number
 - b) **PAN**- number
 - c) Valid license for crane mounted vehicle from the concerned authority along with registration number.
8. **Security deposit:-** You will have to pay 5% Security Deposit of the order value before starting the work.
9. Any damage to any properties during execution of work shall be at the contractor account and cost of such damage will be recovered from him.
10. Offer will be valid for 12 Months.
11. Work will be executed as an when required by the undersigned.
