Please offer your reasonable rates in % percentage only for Enquiry for Supply of Safety Equipments at various Substations & LMSDN, under EHV O&M Dn. Ratnagiri.

**Terms and Conditions:**

- 1) **Due Date** : The quotations complete in all respects, dully sealed & super scribed should be submitted to this office on or before dt. **26.10.2018** upto **17:30 Hrs.**
- 2) **Quoted Rates**: The rates should be quoted for approved sample only. The quoted rates should include the cost of material, transportation, loading & unloading charges etc. The taxes applicable if any should be quoted seperatly.
- 3) **Documents required**:
  - a) PAN/ TAN registration certificate,
  - b) Valid GST registration certificate
  - c) Proof of firm being registered as shop establishment/firm/ Company as applicable.
  - d) Certificate of Authorized dealership/ distributorship preferably.
  - e) Certificate of performance of same type of work executed preferably.
  - f) Test certificate of product from manufacturer.
- 4) **Delivery Period**: Material should be delivered within 15 days from the date of the issue of order at MSETCL Executive Engineer, EHV O&M Division, Ratnagiri. Three days will be reckoned for transit. The condition for delivery should be mentioned specifically otherwise, it will be presumed that you will supply the material within stipulated time.
- 5) **Specifications**: The materials offered should strictly conform to the specifications. Wherever asked for, the necessary test certificates must accompany the consignment. If necessary, the material will be tested before / after delivery to ensure that it conforms to the specifications. If the same is not conforming, then the whole lot will be liable for rejection.
- 6) **Quality of Supply**: The material should be supplied as per specifications mentioned in Schedule 'A'. and guaranteed for 12 months from date of supply. **Also to note, Sample of Electrical Rubber Hand Gloves, Safety Helmet & Safety Belt as per applicable standard & specification should be approved by the Executive Engineer EHV O&M Division, Ratnagiri & committee formed on dt. 22.10.2018 at 15 Hrs.**

- 7) **Security Deposit**: 10% of the value of order is to be paid as Security Deposit by Cash / D.D./BG in this office within 7 days from the date of intimation by this office. No. Interest will be paid on this amount and this will be refunded after completion of contract period satisfactorily & NOC from the concerned In-charge.
- 8) **Validity of Offer** : The offer should be valid for our acceptance for a period of 90 days from the due date of opening.
- 9) **Agreement Bond**: You should have to furnish agreement bond on the stamp paper of Rs. 500/- within 7 days from the date of issue of order. Cost of Stamp paper should be borne by you only.
- 10) Quantity as per schedule A & Quality as per sample approved.
- 11) **Risk Purchase**: In case of failure to execute the order, the same will be purchased from other agency at our description and difference in cost will be recovered from the tenderer in addition to forfeiture of S.D.
- 12) **Income Tax**: As per govt. rule Income tax at source will be recovered from your bill as per rules. Your Income tax No. may be informed to this office.
- 13) **Terms of Payment**: - The bills should be submitted in triplicate to Executive Engineer, EHV O&M Division, Ratnagiri. 100% payment will be made on production of following documents
  - a) Invoice b) Proof of material receipt from EE, EHV O&M Division Ratnagiri or his representative. c) Guarantee Certificate d) Excise duty Gate pass if any.
- 14) The material should be supplied to Office of The Executive Engineer, EHV O&M Division, Ratnagiri, Mirjole MIDC Road Kuwarbav within delivery period mentioned above.
- 15) **Penalty for late delivery**: In case, material is not delivered in stipulated time the contractor shall be liable to pay penalty at ½% per week subject to maximum 10% of the order value.
- 16) **Deduction**: Any amount or amounts which become payable by the contractor to the MSETCL under particular contract may be deducted by the purchaser from any amount / amounts due or becoming due by him to the contract under the same or any other contract.
- 17) **Jurisdiction** : All disputes, differences related to the contract if any, the legal jurisdiction of the court shall be Ratnagiri only
- 18) Please mentioned PAN No./ GST Registration No. if applicable / PF No. & ESI No. if applicable on the bill otherwise bill will be kept pending.
- 19) You are also deemed to be fully aware of the Company's general conditions of contract for work and any ignorance of any of the conditions will not exempt you from your liability to abide by the same.
- 20) You shall not sub-contract without the prior written permission of the company.
