Sealed quotations in sealed envelope are invited from registered contractors/bidders for comprehensive AMC of 2 no. Sleek elevator Capsule type Lifts at SLDC, Kalwa on or before 09/11/2018 up to 15:00 Hrs. with following terms and conditions.

Terms & Conditions: ----->

- 1) The quotations submitted incomplete in any respect are liable to be rejected.
- 2.) You should visit the work site before submitting the quotation.
- 3.) Rates quoted should be inclusive of all taxes and firm quotation basis.
- 4.) Rates should be quoted separately on Annexure-A attached herewith.
- 5.) The period of contract shall be for one year.
- 6.) No extra charges for transportation, T&P and Labour, material etc will be paid, it will be arranged by you only.
- 7.) **Payment:** No advance payment will be made.100% payment will be made on monthly basis within 30 days subject to availability of funds.
- 8.) Validity of your quotation should be at least 90 days.
- 9.) Completed Work order/work completion certificate issued by Govt./Semi govt./PSU Undertaking/reputed private listed companies etc. Repair & maintenance of Lifts shall be attached along with your quotation. However the value of single work order shall not be less than Rs.50,000/- in any case.

- 10.) The work shall be carried as per IS standards and procedure and as per directives of site in charge.
- 11.) **Security Deposit:** You will have to pay security deposit amounting 5% of the value of the order which will be refunded to you after satisfactory execution of the order. In the event of unsatisfactory performance of the contract, or non-compliance to T&C this amount will be forfeited.
- 12.) If any loss occurs to MSETCL property during execution of works, you should make it at good at your cost.
- 13.) Company will not be responsible for any accident or damages to any one during execution of works.
- 14.) Quotations received after due date will not be accepted.
- 15.) If any dispute arises, the decision of the undersigned is final & binding on you.
- 16.) **Penalty:** - If the contractor fails to complete the work as per order in stipulated time period penalty towards delay @ $\frac{1}{2}$ % per week maximum to the extent of 10% of order value will be levied and deducted from bill for non execution of the work.
