CORRIGENDUM FOR E-TENDER

In connection to this office E-Tender on SRM portal for “E-Tender for Work of Servicing & overhauling of 245kV, CGL Make Circuit Breaker of 245kV (200-SFM-40A & 200-SFM-40S) Breaker (SP-PN & SP-SP) individual pole & Gang operated type mechanism at various substation under EHV (O&M) Circle, Kalwa. .” (RFX: 7000011136) under EHV (O&M) Circle, Kalwa invites bids (E-Tender) from reputed authorized contractor for the above said work.

The additional Technical Qualifying Criteria for EMD Payment as follows.

1.The Bidder has to pay EMD and tender fees in following cases:

- a) If the Micro / small Enterprises Registration Certificate does not indicate the relevant classification code covering Material/ Service as required against the tender floated.
- b) If the investment in Plant and Machinery or Equipment exceeds the threshold limit indicated in the MSMED Act 2006 (at present the threshold prescribed limit being for Micro- upto Rs. 25 Lakhs : Small – Rs. 25 Lakhs to Rs. 5 crs. as investment in plant and Machinery and for Micro – upto Rs. 10 Lakhs to Rs. 2 crs. as investment in equipment).

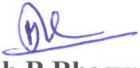
2.In care of works Contract, if the Micro and Small Enterprises submits that the enterprise shall supply all the materials of intended works contract, manufactured from its won unit, then it shall be eligible for exemption of payment of EMD & Tender fees to MSETCL. However , an undertaking duly notarized from Micro and small Enterprises to this effect is to be submitted along with bid.

3.The works contractor except as stated above and Traders are excluded from the benefit of EMD and Tender fees, hence shall be required to pay EMD or tender fees while participating for e-tender process of MSETCL.

4.The registration certificate as submitted by micro and small enterprise should be valid on the date of submission of bid and the validity of the same should be certified by the Chartered Accountant in practice.

Note:- In case, the micro and small enterprise (who have been exempted from payment of EMD / Tender fees) does not accept the tender being L1, then such micro and small enterprises shall be debarred from the bidding process for all tenders at MSETCL for next 2 years from the date of non- acceptance of L1 bid and this is to be clearly mentioned n all tenders.

All other terms & condition are same & available on SRM tender portal.
