7. Work is to be carried out strictly as per the standard specification and as directed by the Engineer in Charge. Mode of measurements will be as per P.W.D. practice.
8. Validity of rate shall be applicable for 60 days from the date of opening of E-enquiries.
9. In case of any dispute decision of the Executive Engineer ( C ) EHV CCCM Division Kolhapur will be final and binding on the contractor.
10. If any damages occur to the Company's property during execution, contractor will have to make them good at his own cost.

11. You have to quoted your offers considering rate of GST. If the contractor is registered in GST, it is contractors responsibility to pay the GST to appropriate Government authority. Incase of GST unregistered contractor, GST as per prevailing rate of bill amount will be recovered from the bill and same will be directly paid by this office to government authority.
