TERMS AND CONDITIONS:

Submission of bid

Two bid systems should be followed for submitting the offer. Uploading of required documents shall be done on MSETCL's SRM E-tender website <https://srmetender.mahatransco.in/>
Your offer should be submitted in two separate bids – **1. Technical Bid & 2. Commercial Bid**

- 1. Technical Bid** - This should contain following documents certificate/ as a proof of qualifying pre-requisites, brochures, attested certificates etc.

B. Commercial bid:-

Bidder should upload the digitally signed price bid under commercial bid online.

1. Techno-commercial bid will be opened online for all received bids. After verifying the all documents /certificates submitted in techno commercial bid for prequalification as mentioned above, if it is found that, the tender fulfills the desired prerequisites; the price bid will be opened online. If the same is not found to be meeting the prerequisite, the commercial bid shall not be opened. Tenders with incomplete details or not submitted in prescribed tender form etc. are liable to reject.
2. This office reserves all the rights to reject any or all tenders without assigning any reasons thereof.
3. The technical documents should be uploaded in the technical bid & commercial documents /offer/price bid should be uploaded separately, in case both technical & commercial bid are uploaded in one file wrongly, the offer will be rejected.

- 1) **SCOPE OF WORK:-** This tender is for AMC for providing pest control and anti-rodent treatment to kill rat and reptiles at BCU rooms, control and relay panels and cable trenches and mosquito control service at 400 kV Chakan s/s.
- 2) **PERIOD OF CONTRACT:** The total period of contract is 12 months from the date of receipt of order or intimation given by this office.
- 3) **VALIDITY of bid:** - All responses shall be open for acceptance by the Company for a period of 90 days from the date of opening of the quotation and the agency shall be bound to carry out the work on such acceptance within this validity period. All bids submitted against this tender shall be deemed to comply with the conditions unless otherwise agreed by the Company.
- 4) **PENALTY:-** If you fail to execute the work within stipulated time as mentioned above, you will be liable to pay penalty at the rate of 1/2% per delayed day, subject to a maximum limit of 10% of the total value of the order.
- 5) **SUBMISSION OF BILLS:** - The R.A. bills for the work as per Schedule 'A' along with monthly visit report duly signed by sub-station in-charge should be submitted in triplicate on the name of Executive Engineer, M. S. E. T. C. L. 400kV Receiving Station (O&M) Division, Chakan to concerned Engineer-in-charge . The M.B. recording of the bills will be done by Engineer-in-charge. After receipt of bills from the concerned Engineer-in-charge, auditing will be done at Division Office and payment will be effected accordingly subject to availability of funds.
- 6) The monthly visit report duly signed by the Engineer-in-charge & the representative of the contractor and the work completion report stating the details of work done by the contractor **monthly** should be submitted along with bills.
- 5) **QUALITY OF WORK:** Quality of work to be carried out should be strictly confirmed to our specification, otherwise it will be rejected and contractor has to redone the same at his cost and risk only
The work carried out by the contractor if found defective due to bad workmanship, that should be redone by contractor free of cost, if reported
The prior permission from the concerned Engineer-in-charge is to be taken by the Contractor before starting the work. **The work should be executed as per Schedules enclosed and as per instructions of the concerned Engineer-in-charge.**

- 7) **GENERAL:** You should make yourself fully aware of M.S.E.T.Co.Ltd.'s general condition of contract for supply of material and execution of work.
- 8) **PAYMENT:** - Payment will be made to you against after confirmation of work carried out from field in-charge Engineer within reasonable period subject to availability of funds by this office. The auditing will be done at Division office after receipt of bills through concerned section in charge duly recorded in MB.
- 9) In case of difference of opinion about any interpretation of any clause of term and condition arising during the period of the contract the decision of the undersigned will be final and binding on you.
- 10) **TERMINATION OF CONTRACT:-** The undersigned reserves the right to accept or reject the enquiry in part or full. The undersigned reserves the right to terminate the contract at any time during the contract period by giving appropriate notice of 7 days, if it is found that the contractor is not able to cope up with or discharge duties satisfactory/or not able to execute the work as per the order conditions. The discretion of the contract operating authority shall be final & binding on the contractor.
- 11) **INCOME TAX & WORK CONTRACT TAX:** -Income Tax & Work Contract Tax (if applicable) will be deducted from the contractor's bill.
- 12) **AGREEMENT:-** The contractor will have to execute an Indemnity Bond on **Stamp Paper of ₹. 500/- at his own cost before commencement of work.**
