Terms & conditions:

- 1) The quotation must be forwarded in sealed envelope duly super scribed with all details i.e.

- The rates should be quoted for hiring charges on per day basis, over time charges per hours & halting charges; exclusive of all taxes and any other contingencies etc.
- 3) Income tax at source as per rules will be deducted from bill as per the prevailing rates.
- 4) The mileage per liter of the vehicle should not be less than 11 km/ltr.
- 5) The Quotation must be written with ink or typewritten, any scratching or over writing must be initialed.
- 6) The period for hiring of vehicle will normally be upto 01st April 2020 from the date of engagement of vehicle, however if MSETCL's vehicle is allotted by CO Mumbai the hired vehicle will be discontinued by giving 15 Days notice.
- 7) Only fuel (i.e. Diesel) will be supplied by MSETCL; no extra charges will be paid for vehicle driver, repairs, oil & all other taxes & duties.
- The rates quoted should be valid for at least one year from the date of placement of order or actual use of vehicle.
- 9) The Working hours will be normally from 09:00 to 20:00 hrs on working days. However, in case of emergency, it will be required beyond 20:00 hrs or before 9:00 hrs & on holiday also.
- 10) Any kind of vehicle breakdown should be attended by owner. He should have valid license to drive such type of vehicle.

- 11) All the provisions under rules and laws regarding registration of vehicle, taxes etc. should be borne by vehicle owner.
- 12) If it is found that vehicle is not giving satisfactory service, the contract is liable for cancellation after in the case
- 13) Vehicle should be able to use on country roads in all over Maharashtra, where EHV sub-stations/ lines work are going on.
- 14) In case of failure of vehicle due to any reason, the vehicle owner has to provide another same type of vehicle on same rates & terms condition without any delay.
