TERMS AND CONDITIONS

- 1. Rates shall be quoted as per the schedule "A" enclosed. Any changes must be brought out clearly.
- 2. The rates should be inclusive of all taxes & levies with To & Fro charges.
- 3. Quotation must be submitted along with the Xerox copies of all the documents pertaining to the Air cooler viz. Purchase invoice, Servicing receipt., Specification details etc.
- 4. The Electricity charges shall be borne by MSETCL.
- 5. During order period, Air cooler should be in good working condition.
- 6. All the repairing, breakdown and maintenance charges will be borne by the contractor & alternative arrangement of air cooler shall be made by you immediately without any extra charges to MSETCL.
- 7. It should be seen that Air cooler is kept in good running condition. The model of the Air cooler should not be more than 3 years old.
- 8. In case any accident, mishap occurs during transportation, all the liabilities will be at contractor's cost & risk & alternative arrangement of air cooler shall be made by you immediately. M.S.E.T.C.L. will not pay any compensation to the contractor against any damages to the air cooler or injuries to the workmen arise at any circumstances.
- 9. Bill will be paid every month for actual working months and you will have to submit the bill in triplicate to the Executive Engineer, EHV Project Dn-1, Pune.
- 10. Applicable taxes as per the prevailing rates will be deducted from your bill. You should submit Xerox copies of PAN Card, Shop act license & GST registration along with quotation. PAN Card No,mobile no. should be mentioned on quotation & bill invoice.

- 12.Duration of hiring of Air cooler shall be up to 30.06.2019 from the date of issue of Order thereafter can be extended/reduced if required.
