TERMS & CONDITIONS PART-I

- Following documents are required for qualifying in the Techno-Commercial Bids for opening of the Price Bids.
 - a. The Contractor should have previous experience of executing similar works in MSETCL or any other Government Utility, which should be of within last 5 years & should have executed at least one work of the order amount equal to 80% of total estimated cost of this Enquiry [Scanned copy of Experience certificate with order copy are to be attached]
 - The material supplied/utilized for work should be of MSETCL's Authorized vendor. (Letter given by MSETCL towards Vendor Authorization for the quoted material is to be attached)
 - c. Name of contractor, firm, e-mail id and contact nos. of the contractor, bank details, full address (address proof to be attached) are to be strictly mentioned in one document (Please attach corresponding scanned copies)
 - d. Registration under GST (if yes Please Attach), if not registered GST will be recovered from quoted rates as per RCM rules
 - e. PAN Card (Scanned copy is to be attached)
 - f. Copies of ITRs filed for last 3 years (Scanned copy is to be attached)
 - g. Audited financial Statement/Net worth certificate for last 3 years (Scanned copy is to be attached)

TERMS & CONDITIONS PART-II

Terms of Work

- All the labours should be issued permanent identity cards from agency's end and it should be produced as and when demanded by MSETCL Officers.
- 2) The contractor should ensure that his/her staff uses the requisite safety equipment. The MSETCL shall not be responsible for injury or death of your labour during the course of work. You will be solely responsible for compensation or medical treatments etc. You will discharge all the liabilities arising out of such accident. The labour should be duly insured against such eventualities.
- 3) The contractor shall be responsible for all the liabilities as per statutory requirements for the labour/workers employed by him for the said work and the contractor shall indemnify MSETCL in the event of any untoward incident till the completion of the work.
- 4) The rates quoted shall be inclusive of cost of material/labor charges (whichever is applicable), transportation, material & requisite T&P required for execution of work, lodging boarding, incidental charges, etc. The condition for taxes shall be mentioned clearly in price bid. If nothing is mentioned regarding taxes, it will be treated as rates quoted are inclusive of all taxes.
- 5) The work carried out and material supplied shall be guaranteed for 12 months. During guarantee period, the contractor shall remain liable for repair, replacement of any defective part of the works including all associated activities of dismantling/re-erection, etc. performed under the contract.
- 6) This contract does not confirm any right to your labours to be absorbed in company's services.

Terms of Payment

- 1) Payment: Payment will be made by the S.E., EHV (O&M) Circle, Panvel within reasonable time after completion of the work satisfactory in each month and on receipt of your bill in triplicate and certificate obtaining from the In-charge for the work executed.
- 2) Any amount which becomes payable by you to the Company under this contract can be deducted by the Company from any amount or any amount dues on you. The amount of security deposit paid by you will also be adjusted against such payments.
- 3) GST,TDS, Labour cess at prevailing rate will be deducted from your bill as per rules and applicability.
- 4) You will have to pay the security deposit @ 10% of the order value shall be paid by you before taking the work in hand.

Material Supply/Work Completion (whichever is applicable):

The supply or material or the completion of work (whichever is applicable) will have to be done within stipulated time.

Penalty for a breach of contract:

- 1) Penalty @50% of the daily rate will be charged for not carrying out work on any day.
