## TERMS AND CONDITIONS OF CONTRACT

After the receipt of the final work order, the contractor shall enter into an agreement with the Company, in the prescribed format before commencement of work. Untill the agreement is executed, the company will not be liable to pay, nor shall the contractor be entitled to claim amount due or payable under the contract. The necessary stamp duty for the agreement shall be borne by the contractor.

The scope of works includes providing providing the services of various outsourcing persons (Peon, computer operators(Typist & steno typist)) under EHV(O&M) Division, Nanded.

The expectations from the deployed are

i) Preferabally, they shall have similar work experience.

ii) In good physical & mental health, devoid of bad habits like drinking etc.

iii) Polite & well behaved.

iv) Preferably in between 18 & 40 years of age.

You should pay security deposit equivalent to 5% of the value of the order. Security Deposit is payable by (a) Cash (b) D.D. (c) Bank Guarantee from a nationalized scheduled Bank. The S.D. will be refunded after satisfactory completion of the work

The contract period shall be operative for 2 months or till the exhaust of order amount or Finalization of Tender at Circle Office, Parli whichever is earlier.

5) OPERATING AUTHORITY:

The Executive Engineer, EHV O&M Dn. Nanded will operate this contract.

6) PAYMENT OF BILL:- The monthly bill in triplicate should be submitted to the EHV O & M division office Nanded at the end of each month along with the attendance sheet for the month. The Division office will effect the payment.

Penalty @ 1% per day/part of payment approved rate thereof subject to maximum 10% of order value will be deducted from your bills as penalty in case you default in providing Outsource persons during contract period. The deduction will be limited to the actual period of default. In case if outsource person is absent on his duty without intimation, then Rs150/- per day per person will be deducted from his payment.

- 8) TAX DEDUCTION AT SOURCE: i) In accordance with I.T. Act 1961, I.T. will be deducted at source at the prevailing rates from the bills. Similarly any other tax deductible at source, if applicable to this particular contract, as per statutory provisions (laid down by Central or State Government.) will also be deducted from the bills at the prevailing rates.
- 9) Out-Sourcing Staff cannot claim in future for job in MSETCL. Undersigned reserves the right to disqualify outsource staff.

10) DAMAGE TO PERSONS AND PROPERTY:

The contractor shall indemnify the MSETCL against any losses and claim in respect of injuries or damage to any persons, material or physical damage to any property whatsoever, which may arise out of or in consequence of the execution of the work.

11) TERMINATION OF CONTRACT:

The undersigned reserves the right to cancel the contract, after giving due notice to the contractor, in the event of the breach of contract and unsatisfactory services in any respect.

12) JURISDICTION:

All disputes, differences related to the contract shall be subject to the jurisdiction of Nanded Court only.

- 14) You will have to maintain all records as required under labour laws labour licenses, P.F. Registration, ESI regulations, Minimum Wage Act etc.
