“providing and fixing exactly identical of HV R phase Bushing of 245 KV, 800A bushing for 25 MVA 220/33 kV BBL make PTF at 220 KV Dondaicha S/s under EHV O&M Div Dhule as per Schedule ‘A’ ”

The Quotations giving full particulars should reach this office on before **24.05.2019 up to 15.00 Hrs. positively i.e. EHV O&M Division Office, MSETCL, Dhule.**

Place of work – 220KV Dondaicha S/S

1. “The bidder should quote rate including Labour charges, labour cess & incidental charges as per applicable rate & relevant act Only exclusive of GST. The GST should be quoted separately.”
2. Following documents are required with quotation:

1	Full name of quotation submitting firm & full address of the same.
2	Contractors name, permanent address & Address Proof.
3	Valid shop act & establishment registration/grampanchayat NOC as applicable.
4	Full name of quotation submitting firm, Bank name, bank address, bank account details, PAN No. Should be submitted.
5	GST Registration Certificate. If not applicable then undertaking regarding that.
6	Valid Electrical contractor license.
7	The agency should have experience regarding providing and fixing PTF / ICT bushing for voltage level minimum 132KV or above in MSETCL or PGCIL or any Government sector.

Failing to submission of above said documents will lead to reject the offer

3. If validity of any license / certificate expires during order period, you will have to renew the same and submit the copy to this office. Payment will be effected for valid period only.
 - a. This office reserves all the rights to reject any or alids without assigning any reasons thereof.

b. The offer shall be valid up to 120 days from the date of opening of the quotation/bid or as per decision of higher authority.

4. The contractors will have to bear GST applicable from time to time by the Government.

5. The order value will be limited upto Rs.4,95,139=00 only In words: Rs.Four Lakhs Ninety Five Thousands One Hundred Thirty Nine Only including all taxes, Labour charges, labour cess & incidental charges as per applicable rate & relevant act.

6. The contractor has to pay **10% of the Order value as a Security Deposit, in DD only.**

Same will be refunded to the contractor after completion of guarantee period.

7. The contractor has to execute the agreement as per the provision of 'Mumbai Mudrank

Adhiniyam 1958, Clause No. 34' with **Rs.500=00 stamp duty** before starting of the work.

8. Liquidated Damages / Loss due to theft: - Any damage or loss to M. S. E T. Co. Ltd's property due to your employees' negligence during the course of contract shall be on contractor's part and same shall be recovered from the bill.

9. The concern sub-station in-charge will be operating officer for this work contract. The work is to be carried out under supervision & as per the directives of operating officer i.e. concern sub-station incharge.

10. The M. S. E. T. Co. Ltd. shall not be responsible for injury or death of your employee during the course of contract. Contractor will have to provide safety equipments to his employees.

11. Contractor will be solely responsible for compensation or medical treatment etc. for all the liabilities arising out of such accident. It shall be the sole responsibility of the contractor to observe all the relevant acts and regulations along with amendments thereto framed by the Government from time to time. The MSETCL shall not be responsible for violation of any of the above stated regulations / Acts etc. by the contractor.

12. Instructions given by sub-station in-charge regarding work in Live Switchyard should be strictly followed by Contractor.

13. LIQUIDATED DAMAGES & PENALTY:

A. If the agency fails to complete all the works within the time frame stipulated, the MSETCL shall levy liquidated damages for breach of contract

B. The Liquidated damage shall be levied at the rate of 1/2% (Half Percent) per week of delay, subject to the maximum of 10 (Ten) % of the contract price for the entire scope of the work.

C. In case of such delay, the contract may be terminated by the competent authority as per general rules and regulations of MSETCL and the balance work shall be got completed through separate contract at his risk and cost.

14. **ACCIDENT:** If any fatal or non fatal accidents occur during the course of work to your labours, the MSETCL will not be responsible. The compensation, if required to be paid will be at your cost & risk only. You will be responsible for the safety of your labours/ employees & also safety of the MSETCL equipment/material. If any MSETCL equipment/material is damaged. You will have to make the loss good at your risk & cost otherwise same will be recovered from your bill.

15. **FIRST AID BOX:** You will have to keep the first aid box & safety measures at site for the labours.

16. **Completion Period:-** The work should be completed in maximum period of 7 days from intimation by sub-station incharge & in a single outage of 12 Hrs. from intimation & directives of concern S/S incharge subject to availability of outages and also work should be completed in outage period scrupulously.

Before quoting also at the stage of execution of work, the concerned vendor should visit the site for confirming the availability of suitable materials, assessing required material, site condition, & circumstances to observe for completion of work as per W.O.

17. The material supplied & work carried out by you should be guaranteed for 12 months from the date of work completion. If any defect occurs within the guarantee period you should have to re-carry out the work / replacement / repair free of cost.

18. During the execution of work if it is found that, the quality of material & workmanship is not as per our satisfaction, the undersigned reserves the right to terminate the contract immediately & recover the penalty as would be deemed.

19. The material should be of good quality & as per standards of MSETCL specifications. The material to be used in execution of the works must be got approved from the sub-station incharge in advance, and only approved materials should be used.

20. The insurance of your labours will have to be done at your cost. If failed to do so any compensation or claim arise will be your responsibility.

21. The time stipulated in the contract for the completion of the work shall be deemed to be the Essence of contract. The contractor shall so organize his resources & perform his work as to complete the work within stipulated time period.

22. **OUTAGES:** Outages as and when required will be arranged by The concern sub-station incharge

23. Acceptance of the work order / LOI shall be treated as acceptance of these conditions of the Enquiry by the contractor.

24. All other standard conditions of contract prevailing in M.S.E.T.C.L.& former MSEB are applicable in this case also.

25. The right to reject any or all quotations without assigning any reason there of is reserved by under signed. Similarly the above work may assign for other lines at same rates / terms & condition .

26. The Sub-stations in charged condition, "prohibited area" declared by Government.. Contractor will have to take all the precautions at his own cost until handing over the site back to MSETCL. If any accident occurs to the labour skilled or unskilled, compensation if any, is to be paid by the contractor at his own cost.

27. Contractor will be responsible for the quality of work & workmanship. The material used to be strictly as per specifications & MSETCL standard.

28. The disputes, if any, shall be subjected to the jurisdiction of the Dhule Court only.
