SCOPE OF WORKS: As detailed in Scope of Work 'A' & 'B'

Terms & Conditions

- 1) Scope of work :- shall be supply & wiring of material as per schedule A & B attached herewith. The work is to be carried out as per instructions of MSETCL concerned authority.
- 2) Security deposit :- The successful contractor will have to pay Security deposit amount 5% i.e. 14920 /- of the total value of order by Cheque or by demand draft to this office.
- 3) The bidder should submit the following original documents / certificates through SRM.

Technical & Financial Criteria :-

Following required documents are to be submitted with enquiry:-

- A. Valid electrical contractor license for undertaking the work.
- B. Registration under Shop and establishment Act.
- C. Pan No. & income tax returns filled in last 3 years
- D. Insurance under work men compensation act.
- E. The bidder must have executed such type of work as mentioned in the enquiry during 1 year in the last 3 years of about enquiry. The bidder should submit the performance certificate from the user in support of such works. The experience certificate from the authority of the rank of Executive Engineer or above in MSETCL or equivalent shall be submitted.
- F. GST registration certificate
- G. List of skilled persons, tech staff with experience & qualification etc.
- H. Constitution of the bidder's firm e.g. partnership deed, article of association etc. if applicable. In case of partnership firm, a letter by all partners authorizing any one or more partner/partners to deal with the board regarding the bid/contract.
- I] As per the circular published by corporate office in r/o exemption of EMD for SSI & NSIC unit, it is to indicate the following condition in field tender or enquiry is as follows:-
"Firms / bidder has to pay E.M.D., for the same or not in following cases:-
 - I) If S.S.I./N.S.I.C. certificate do not indicate material/services required against present tender.
 - II) If turnover or manufacturing capacity exceeds the limit indicated in S.S. I/N.S.I.C. certificate specified by the concerned authority to avail the benefit of E.M.D. exemption. If required E.M.D. is not paid by the bidder, the offer is liable for rejection."

4] The undersigned reserves the right to reject any or all the quotation without assigning any reasons thereof. Any term and conditions found necessary at a later stage will be published Separately.

5]Liquidated Damages:-

- a) If the contractor fails to complete all the works within the time frame stipulated, the MSETCL shall levy liquidated damages for breach of contract.
- b) The Liquidated damage shall be levied at the rate of ½ % (Half Percent) on the total contract price per week of delay, subject to the maximum of 10 % of the contract price with 18% GST extra on Liquidity damage Calculated amount for the entire scope of the work. (for detail refer Circular no MSETCL/F&A/CA/DATE: 01.11.2018).

6]You will be covered under standard terms & condition contained in MSETCL tender & contract for the work.

7]Time limit allowed for the completion of above work is 30 Days from the date of handing over of site. The work completion shall be certified by the engineer in charge.

8]Quoted Rates:- The quoted rates should include the cost of material, all skilled & unskilled labour also the transportation charges etc.

9]Quality of work:- The contractor shall be responsible for quality of material & workmanship. The unused material/waste material should be removed from the site. The site shall be cleaned after work completion.

10] Site Visit:- Information about the work given in specification is purely tentative & may change during actual execution as per site requirement. The vendor is advised to visit & examine the sites of work & their surroundings & obtain for himself, at his own risk & cost, all information that may be necessary for preparing the quotations & entering into the contract for this work. The cost of visiting the site shall be at the vendor's own expenses.

11]Insurance & safety:- The workers insurance & safety shall be covered by the vendor. MSETCL shall not be held responsible & will not pay for any accidents at site during works. It's the vendors responsibility to adhere to all safety norms during the works. Proper tools should be used.

12]Guarantee Period:- The contractor shall warranty/ Guarantee that, the material will be free from defects in material & workmanship for a period of 12 months from the date of final acceptance of works by MSETCL. Any defects developed due to defective materials &/or workmanship during testing & commissioning of equipment or during the guarantee period of 12 months from the date of final acceptance of work by MSETCL, shall be rectified or made good by the contractor at his own cost.

13]Validity of offer:- The offer should be valid for our acceptance for period of 60 days from the date of opening the same.

14]Jurisdiction :- The jurisdiction of all legal proceedings/suits as regards to the works under contracts will be under Thane Dist. Courts in case of any dispute regarding any clause of the work order or works, the decision of the undersigned is final & binding on you.

15] Bill :- The bill in triplicate should be submitted through Concerned Sub divisions & payment will be made subject to the submission of bills with required documents from you and certified by Engineer in charge. The Executive Engineer, EHV Projects Dn, Kalyan shall make the arrangement of payment.

16] In case of such delay, the contract may be terminated by the competent authority as per general rules and regulations of MSETCL and the balance work, if any shall be got completed through separate contract at the risk and cost of the tenderer.

17] The work should be carried out as per standard and to the satisfaction of the Engineer-In-charge.

18] All tools & plants required for the work shall be arranged by contractor at his own cost.

19] The work shall be supervised by Addl Ex. Engr., EHV SS Projects Dn, Kalyan. The contractor should obtain a certificate from concerned Sub divisions for execution of work satisfactorily.

20] The quoted rates should be firm and should include all such as duties, all type of taxes etc. Also mention the SAP vendor number on quotation.


