- 3. The contractor should have experience of similar type of work and should be attached with the offer quotations. Also GST registration no., Shop Act, PAN, TIN etc statutory licenses are to be submitted with offer.
- 4. The rate should be quoted in figures as well as in words.
- 5. If any damage is occurred to the contractor's equipment/T&P OR any accident to your labours/personnel, the M.S. Elec. Trans. Co. Ltd. will not be responsible in any way. Also if any theft/loss of material is occurred, the M.S. Elec. Trans. Co. Ltd. will not be responsible in any way.
- 6. An Income Tax as applicable will be deducted from your bill.
- 7. The work should be completed within **15 working days** from the date of issuing clear work order.

- 8. The work should be strictly carried out as per standard specifications and upto the entire satisfaction of the Manager F&A EHV Project Division Aurangabad.
- 9. The contractor will have to pay security deposit to the M.S. Elec. Trans. Co. Ltd. equal to 5% of the ordered value.
