**TERMS & CONDITIONS:**

1) The E-enquiry document is available on the website: <https://srmetender.mahatransco.in> the tenderer can download the tender document from the above website from date: 27.06.2019

2) **Earnest Money Deposit:** Earnest money deposit of Rs. 5000/- will have to be paid by the tenderer. The tenderer should have to submit their e- offers online well in advance within date and time mentioned as above. Payment of E-tender fees and EMD should be paid by the bidder through online only. Bidder can pay through credit card or Net banking of any bank account.

3) Tenderer should upload the following PDF format copies of documents/certificates online as under

**A) Technical Bid (Qualifying Criteria):** Tenderer should upload the following digitally scan copies of original documents/certificates online under the technical Bid one PDF /JPG file

- i) Clear PAN Card
- ii) Registration of Firm/Shop Act License (valid)
- iii) GST Registration certificate
- iv) Valid Electrical contractor licenses

**B) Commercial Bid:** This Bid should contain only 'Price Bid' duly sealed / encrypted & digitally signed by the contractor.

4) If the tenderer does not fulfill any of the Qualifying Requirement / Qualifying Criterion or **fails to submit any one of the documents mentioned above, his commercial bid will not be opened.**

**5) Rates:** The rates quoted should be firm and no price variation will be accepted. Tax applicable to your firm is to be shown separately by you under the head of taxes in SRM system & it is mandatory. If tax is not or wrong quoted by agency it will be added at prevailing rates (applicable tax at the time of work) by MSETCL side.

**6) Price variation:-** Not applicable to this E-Enquiry.

**7) Signing of Contract(Agreement):** Within 7 days from the date of the receipt of this work order, the contractor shall enter into an agreement with the MSETCL, in the Company's standard proforma using stamp value in accordance with the clause no. 63 of the Bombay Stamp Act (Amendment) 2006. Until the agreement is executed, the Company will not be liable to pay, nor shall the contractor be entitled to claim amount due or payable under the contract. The necessary stamp paper, etc charges for the agreement shall be borne by the contractor

**8) Performance Security Deposit:** Within 7 days from the receipt of the letter of intent /order, the contractor shall furnish a performance guarantee deposit amounting to 5% of the contract value by cash /DD / bank guarantee of a Nationalise / scheduled bank.

**9) Refund of Security Deposit:** The performance Security Deposit will be refunded after satisfactory completion of work with your final bills.

**10) Scope of Work:** - As per **schedule 'A'** scope of work of Tender. *Battery Should be of "Excide" OR "Amaron" make OR any Equivalents make with 24 months warranty.*

**11) Execution of The Work / Work Completion Period:** Work should be started within 7 days from the receipt of copy of work order or letter of indent from Executive Engineer HVDC TL (O&M) Division Office, Jalna and should be completed within 60 days.

**12) Supervision of The Works:** The work shall be supervised by the concerned E.E./division in charge or his representatives. The contractor shall obtain certificate from Concern E.E./division in charge for having executed the work satisfactorily in case of any dispute, regarding method/ producer to be adopted by agency for attending the work against work order the decision of undersigned shall be final and binding on the contractor..

**13) Compensation Under Workmen's Compensation Act – 1923 (VII OF 1923):-** The contractor shall be responsible for and shall pay compensation to his workman / employee as per Act for injuries that may be inflicting on the workmen. In case if such compensation is paid by the Transmission Company , as per Principals under subsection ( I) of Section 12 of said Act, on behalf of the Contractor the amount of such compensation paid shall be recovered in the manner laid in clauses 4 of the relevant section of the Act.

**14) Penalty :-** In case of works are not completed as scheduled, you will be liable to pay at the discretion of the competent authority the sum equal to 0.5% of the contract value per week subject to a maximum of ten percent of work order value as liquidated damages.

**15)** In case of any dispute, the decision of the Executive Engineer, 500kV HVDC TL (O&M) Division Jalna will be final and binding on you.

**16) Applicability of General Conditions of Contract:** Besides all terms and condition mentioned in the tender document the general terms and conditions of contract of MSETCL are also applicable to this contract.
