- 3) QUOTED RATES: The quoted rates should include all skilled and unskilled labour incidental charges etc. Taxes & Charges shall be mentioned clearly. If not mentioned it will be considered inclusive of all taxes & charges.
- 4) The working hours will be 8.00Hrs (i.e. from 10.00hrs to 13.30hrs and 14.00hrs to 18.00hrs, ½ hrs break for lunch).
- 5) The agency has to give the replacement of the Steno-typist in case he remain absent from duty, otherwise the deduction of payment on per day basis will be done from the monthly bill.

- 6) All the statuary Govt. requirements such as EPF, CPF remittance, special allowances, insurance etc will be paid by you. Minimum wages act 1948 should be scrupulously followed.
- 7) PERIOD OF CONTRACT: 01 year from the order date or till completion of order amount.
