TERMS AND CONDITIONS

- 1) **RATES:** Should stand firm at least for three months, otherwise maximum percentage in the rates should be stated.
- 2) **TAXES:** Taxes which are applicable for the said work should be clearly mentioned in the bid/quotation.
- 3) **DOCUMENTS:** While submitting the offer documents such Valid Shop & Establishment certificate as applicable, copy of valid GST registration certificate, copy of PAN card, work experience certificate/copy of work order of similar work executed shall be enclosed.
- 4) **PERIOD OF CONTRACT:** The supply as per SCHEDULE “A” shall be completed within two months from the date of order by the successful bidder.
- 5) **SCOPE OF WORK:** Supply of blue color Silica Gel at various EHV S/stns under EHV O&M Division, Yavatmal. The ordered material should be delivered to respective offices mentioned in Annexure 'A'.
- 6) **QUALITY OF MATERIAL:** The material offered shall be of good quality and strictly conform to the specification. If necessary, the material will be tested before / after delivery to ensure that it conforms to the specifications. If the same is not conforming, then the whole lot will be liable for rejection.
- 7) **SAMPLE APPROVAL:** Sample of blue color Silica Gel to be supplied shall get approved from Executive Engineer, EHV O&M Dn, Yavatmal prior to supply.

- 8) **PENALTY:** If you fail to execute the work within stipulated period mentioned, penalty @ of 1/2% per week maximum up to 10% shall be imposed on the cost of the work.
- 9) **SECURITY DEPOSIT:** The successful bidder will have to pay security deposit amounting to 10% of the total value of order by cash/BG/FDR. The same will be refunded without any interest after satisfactorily completion of work and finalization of bills
- 10) **MSETCL RULES:** In addition to above, the contract will be governed by General terms and conditions mentioned in MSETCL booklet of contract terms and conditions.
