TERMS AND CONDITIONS:

- 1) The quotations should be sent under sealed cover super scribed with "Quotation for work of annual maintenance contract for pest control for the period of July-19 to March -20."
- 2) Your quotation in a sealed envelope super scribed with above enquiry number, EMD receipt date etc. should reach to this office on or before 12.00 Hrs. on 23.07.19 positively.
- The standardized conditions of contract of this company are applicable to this order.
- 4) EMD: You have to pay an EMD amount of Rs.5,000/- to this office in the form of Cash/DD. If exempted for paying EMD please submit the documents as per circular No. MSETCL/Director(Ops.)/10812 dt.10.10.2018.

As per the circular, it is state that "The registration certificate as submitted by Micro and small enterprises should be valid on the date of submission of bid and the validity of the same should be certified by the Chartered Accountant in practice."

Note: In case, the micro & small enterprise (who have been exempted from payment of EMD/Tender Fee) does not accept the tender being L1, then such micro & small enterprises shall be debarred from the bidding process for all tenders at MSETCL for next 2 years from the date of non-acceptance of L1 bis and this is to be clearly mentioned in all tenders.
