

1. The completion period of order will be for 15 days from date of dispatch of order.
2. Contractor will have to pay **Rs. 500/-** towards earnest money deposit (EMD) in cash / demand draft in favour of 'MSETCL' payable at kalyan. The quotation without payment of EMD will not be accepted.
3. Bidder should submit following documents with Quotation:
  - a) EMD paid receipt.
  - b) Experience certificate.
  - c) License under Bombay shop & Establishment Act 1948
  - d) Contractor bank details.
  - e) Pan card No.
4. An agreement on stamp paper (**Rs. 500/-**) should be made as per procedure and cost will be bear by Agency.
5. The contract is purely based on work specified and therefore the statutory responsibility of labours provided by you lying with you only.
6. The tools & tackle required for work is to be provided by you for that company will not give any extra amount.
7. The Deputy Executive Engineer (O) will be officer In-charge to supervise work.
8. If any labour/worker met with accident, it is the responsibility of the contractor to admit any provide first aid to the worker/labour and pay the compensation as per the rule/law in force. MSETCL will not pay any compensation.
9. Contractor will have to pay 5% Security Deposit of the order value within 7 days from the date of order.
10. If the work is not carried out satisfactorily as directed by the officer in charge then the penalty will be charged @10% of the bill.
11. Work should be carried out on time as directed by Officer In charge.
12. Contractor have to submit the bill for the work carried out the officer in charge concerned in
  - a. Triplicate and same will be paid within 30 days. The payment shall be made on the basis of
  - b. Certification of satisfactory work done from officer In charge.
13. The officer in charge will decide the deduction in bill for the incomplete work.
14. Income tax will be deducted from the bill as per Rule.
15. If the work is not completed by the contractor the same will be get done from the other agency and amount so paid will be deducted from any pending bill of the contractor.
