## **TERMS AND CONDITIONS:-**

- 1. Your quotation in sealed envelope, superscribed with above enquiry No. & Date etc. Should reach to this office on or before **29.07.2019 upto 17:30.**
- 2. Quotation should be duly filled in all respect otherwise it will not be considered.
- 3. The rate should be quoted inclusive of all taxes. Any changes must be brought out clearly
- 4. The work under sr no- 1&2 will have to be completed within 60 days from the handing over of site.
- 5. If the work is not completed as per stipulated period penalty will be charged as per Company Rule.
- 6. The payment will be effected on actual measurement basis as per the Schedule given above.
- 7. The grass shall be cut and taken out of premises as per the instructions of the Addl.EE. EHV line projects sdn, Baramati or his authorized representative. The work shall be carried out without disturbing the stacking of the materials and strictly under the supervision of incharge. Removed grass should be dumped at sufficient distance away from M.S.E.T.C.Ltd.. premises without causing hindrance to the public utilities. For any complaint arising out of such acts, the contractor will be fully responsible.

8. Contractor should possess license to handle, transport & spray such chemicals for weed control from appropriate authority and documentary proof should be attached. Copy of updated Shop Act License, GST Registration copy if GST is not applicable then submit the declaration about the same, PAN card copy etc should be enclose along with quotation.

9. Provision monthly R.A. bill can be made for annual maintenance.

10. It will be the sole responsibility of the contractor for injuries or damages to any property, material or physical damages to any person whatsoever which may arise out of or in consequence of the execution of the work. The M.S.E.T.C.L will not pay any compensation

to the contractor against any damages or injuries arise to his men while executing this work.

11. The work shall be supervised by Add.EE EHV line projects sdn, Baramati. The contractor shall obtain a certificate from the Add EE EHV line projects sdn, Baramati for having

executed the work satisfactorily.

12. Income Tax as per Govt. rate will be deducted from contractor's bill.
