TERMS AND CONDITIONS

- 1) **RATES:** Should stand firm at least for three months, otherwise maximum percentage in the rates should be stated.
- 2) **TAXES:** Taxes which are applicable for the said work should be clearly mentioned in the bid/quotation.
- 3) **DOCUMENTS:** While submitting the offer documents such as electrical contractor license, copy of valid GST registration certificate, copy of PAN card shall be enclosed.
- 4) **WORK COMPLETION PERIOD:** The work shall be carried out & completed within outage period from handing over of site.
- 5) **SCOPE OF WORK:** Providing & Fixing of End Terminal Kit to 33 KV power cable of 132/33 KV, 25 MVA, TF-2 at 132 KV Darwha S/stn under EHV O&M Division, Yavatmal **as per Schedule-A.**
- 6) **QUALITY OF MATERIAL:** The material offered shall be of good quality and strictly confirm to the specification.
- 7) **PENALTY:** If you fail to execute the work within stipulated period mentioned, penalty @ of 1/2% per week maximum up to 10% shall be imposed on the cost of the work.

- 8) **SECURITY DEPOSIT:** The successful bidder will have to pay security deposit amounting to 10% of the total value of order by cash/BG/FDR. The same will be refunded without any interest after satisfactorily completion of work and finalization of bills
- 9) **MSETCL RULES:** In addition to above, the contract will be governed by General terms and conditions mentioned in MSETCL booklet of contract terms and conditions.
- 10) **DEDUCTIONS:** Income Tax, labour cess & GST TDS will be recovered as per rule from your bills.
