- 8. Penalty about ½% Per week or part there of and mazimum up to 10% of the order value for the delay is supply the material after due date of supply.
- 9. The material in all respect shall incorporate the highest quality of modern design and workmanship and should give satisfactory and efficient performance under warranty Period. If any tyre is found to be defective then the same shall be replaced by you immediately.
- 10. The offer shall please be sent under sealed envelope, super scribed with above enquiry No. & Date etc.

- 11. The Validity of your quotation should be minimum 2 months.
- 12. Income tax will be deducted as per Government rule.
