## **2. Price Bid (Part-II) –**

### **Bidder should upload the digitally signed price bid under Price bid online.**

- Techno-commercial bid will be opened online for all received bids. After verifying the all documents / certificates submitted in techno commercial bid for prequalification as mentioned above, if it is found that, the tenderer fulfills the desired prerequisites; the price bid will be opened online. If the same is not found to be meeting the prerequisite, the price bid shall not be opened. Tenders with incomplete details or not submitted in prescribed tender form etc. are liable to reject.
- This office reserves all the rights to reject any or all tenders without assigning any reasons thereof.
- The technical documents should be uploaded in the technical bid & commercial documents /offer/price bid should be uploaded separately, in case both technical & commercial bid are uploaded in one file wrongly, the offer will be rejected.
- The offer shall be valid up to 120 days from the date of opening of the tender.

## **TERMS & CONDITIONS**

1. **SIGNING OF CONTRACT:** The contractor should submit an agreement of amount mentioned in work order of Rs. 500.00/- with the MSETCL within 7 days from the date of receipt of the work order. Until the agreement is executed, the MSETCL will not be liable to pay, nor shall the contractor be entitled to claim amount due or payable under the contract. The necessary stamp duty for the agreement shall be borne by the contractor.
2. **SECURITY DEPOSIT:** The Tenderer will have to pay security deposit within 7 days from the date of receipt of the work order, amounting to 5% of the value of the contract in the form of Cash/FDR/D.D./BG .

D.D. should be any of Nationalized/ Scheduled Bank in the name of EE, EHV O&M Pimpri-Chinchwad Division, Pune, payable at Pune. FDR/BG should be any of Nationalized/ scheduled Bank valid upto expiry of guarantee period. **In case of delay in S.D. payment interest @rate of 18% p.a. will be levied on you till the date of submission of S.D.**

In the event of the contractor failing to deposit such security within the stipulated period the company shall have full discretion at its own to cancel the acceptance of the said tender without communicating it to the tenderer. The security deposit will be returned after the expiry of the satisfactory completion of the guarantee period of the work. No interest will be allowed or paid on this deposit.

3. **EARNEST MONEY DEPOSIT:** - Each tenderer shall be required to pay Earnest Money Deposit @ 1% of estimated value **before submission of tender by online only**. No Tender will be considered unless the earnest money is paid as above. Also request for paying earnest money deposit after opening of tender will not be considered.

The EMD will be refunded only after finalization of the tender order. Earnest money deposited will be refunded online through SRM System after approval from competent Authority. EMD will be credited to the bank account maintained by bidder in vendor Profile in SRM system. Bidders are requested to ensure that the bank details i.e. Account No., IFSC Code, Account Holder Name, Bank Name, Bank Address are correctly maintained in SRM System and update the same, if required.

It may be noted that:

- 1) In case bank details are not maintained by the bidders in their SRM Vendor profile, EMD will not be refunded online and MSETCL will not be responsible for the delay.
- 2) MSETCL will not be responsible for any financial implications in case incorrect bank details are maintained by the bidders as it is the sole liability of the bidder to maintain correct bank details to facilitate online refund of EMD.”

EMD will be forfeited by the M.S.E.T.C.L.if.....

- a) Tenderer withdraws the tender offer during validity.
- b) In case tenderer fails to pay the prescribed security deposit against an order placed within the prescribed period.

The earnest money deposit should be paid by the bidder online only. No interest shall be allowed on the earnest money deposit in respect of unsuccessful tenderers.

4. **VALIDITY OF TENDER:** -Tender shall remain open for acceptance for a period of 4 months from the date on which it is due for submission. During this period, no bidder shall be allowed to withdraw his tender. Any such withdrawal during the said period will entitle the forfeiture of the earnest money deposited by the tenderer. As such the offer submitted by the bidder must have a validity of minimum 120 days from the last date of submission of offer.

5. **ACCEPTANCE OF TENDERS:** The Company does not bind itself to accept the lowest or any tender neither will any reason be assigned for the rejection of any tender. It is also not binding on the Company to disclose any analysis report on tender.
6. **DISCARDED TO TENDER CONDITIONS:** The Company reserves to itself the right to reject the tender.
7. **VALIDITY OF ORDER:-**The period of contract shall be 12 months from the date of issue of work order or exhausting of order amount whichever is earlier.
8. **EXECUTION OF WORK: -** The authorized representative of the contractor will visit the sub-stations mentioned in schedule at least once in a month and attend the work of weed control as per instructions of Sub-Station in-charge. The switchyard should be maintained clean and free from growth of any type of grass, shrubs, weeds etc. The safe & lawful disposal of the grass is to be done by the contractor. All the activities will have to be carried out in consultation with sub-station in-charge only.
9. **SUPERVISION OF WORK: -** The work should be carried out under the supervision of the concerned substation incharge. The work carried out without supervision will not be recorded and payment will not be released for such works which may please be noted.
10. **PENALTY FOR LATE EXECUTION OF WORK: -** In case, the work not completed as per Schedule in the specified time, the contractor shall be liable to pay penalty at 1/2% per day subject to a maximum 10% of the value of order. Also any loss to MSETCL property or equivalent etc. due to your negligence will be penalized & will be recovered from the bill.
11. **FAILURE OF EXECUTION OF THE WORK:** For failure to execute the work as per given Schedule "A" against the order in part or full, within the stipulated period, the Company shall be at liberty, without further notice or reminder to the contractor to get the same work done on account of and at the risk & cost of the contractor and claim for the difference in price and for all expense whatsoever incurred in getting the said work done and the same shall be recovered from any payment due to the Contractor from bills or deposit or on any account with any MSETCL's Offices; such expenses will also include 15% Supervision charges & your Security Deposit will be forfeited.
12. In case the work is not executed partly or fully the balance work will be got carried out from Some other agency even at higher rate and difference in cost will be recovered from your pending bill with the Company & Security Deposit will be forfeited in addition to above.
13. **PRECAUTION:-**All equipment lines & bus are in charged condition .Tenderer will have to take precaution at his own cost until handing over the site to MSETCL.
14. **VARIATION IN ORDER AMOUNT DUE TO VARIATION IN TAXES :-**
  - a) In case any existing GST or duties are enhanced or any tax or duty is newly introduced by Govt. Applicable for this work with effect from the next day of first working day of the calendar month just previous to the month of due date of submission of the bid and if the contractor is required to pay additional amount towards this tax or duty then the MSETCL shall reimburse the contractor, at actual, the additional tax or duty so paid by the contractor against submission by the contractor of documentary evidence to the satisfaction of the Owner. The breakup of prices & percentage of taxes and duties considered for quoting is to be given in a separate schedule other than price schedule.
  - b) The above provision is applicable for any reduction in duty or tax from the next day of the first working day of the calendar month just previous to the month of due date of submission of the bid. Accordingly the contractor shall pass on the benefit due to reduction in duties and GST etc. to the Purchaser.



- c) If any statutory variation regarding enhancement of existing tax or duty or introduction of a new tax or duty applicable for this work takes place in the extended period of contract, no claim for additional cost due to statutory variation shall be entertained by the Owner.
15. The contractor should appoint an supervisor with skilled team to carry out the work. The contractor should follow the instructions given by the engineer In charge.
16. **ACCEPTANCES OF CONTRACT WORK:** The work against this contract will be subject to the approval of the Officer-In-charge or any other officer deputed for the purpose. He is at liberty to reject any or the whole without assigning any reason and his decision in respect of such rejection will be final.
17. **TERMINATION OF CONTRACT:** The undersigned reserves the right to cancel the contract after giving due notice of 3 days to the contractor, in the event of the breach of contract in any respect. Undue delay in completion of contract work is also liable to getting the work done through other agencies at the risk and cost of the contractor.
18. **SUBMISSION OF BILLS / PAYMENT OF BILLS:** The sub-station wise quarterly single R.A. bills for the work as per Schedule 'A' along with monthly visit report duly signed by sub-station in-charge should be submitted in triplicate to the Executive Engineer, EHV O&M Pimpri Chichwad Division Office. The M.B. recording , service entry , Scrutinizing & auditing of the bills will be done at Division Office after receipt of satisfactory work done certificate from respective SSI and payment will be effected accordingly subject to availability of funds.
19. **OTHER CONDITIONS OF TENDER AND CONTRACTOR:** The tenders and orders / contract placed against this specification shall be governed by the Company's General Conditions of contract, the tenderer is deemed to be fully aware of these conditions and ignorance thereof shall not exempt him from his liability to abide by these conditions.
20. The enclosed schedule, tender notice, tender form, and terms & conditions also form a part of this specification.
21. In case of any dispute whatsoever, regarding interpretation of the terms and conditions, or quality, the decision of the Executive Engineer, EHV O&M Division Pimpri Chinchwad, Pune will be final and binding on the contractor.
22. **LOSS OF MATERIAL:** You will have to keep your material in safe custody at your end. The Company will not be responsible for the loss of the material kept at Company's site. The accommodation for your staff will not be provided by the Company.
23. **TOOLS, PLANTS & MACHINERY:-** The contractor shall have sufficient and adequate T&P with him. The representative or authorized representative of the owner will verify the workability & availability of T&P owned by bidder. If the inadequacy is observed, bidder should comply all short falls and after written consent of EE/Addl.EE, he should start/commence the execution. Though it is verified by owner, it does not mean that owner is responsible to provide shortfall of T&P & machinery to execute the work. It is sole responsibility of bidder to complete the work within stipulated time period. The Bidder shall bring his all tools, plant and machinery for this work. The contractor shall have to make his own arrangement for Transport of man power, tools and Tackles in adequate quantity .
24. **HOUSING & ACCOMMODATION:** Bidder will make his own arrangement for the housing of his staff and labours.
25. **WORKING HOURS & OTHER WORKS AT SITE:** The bidder shall work amicably and co-operate with the Company in case and other work also is being carried out at the site. As such, it may please be noted by the bidder that he has to work without causing any

interference or disturbance to the Departmental work or work of the other bidders. The hours of work for the labour employed by the bidder will be approved by the Engineer-in-charge.

26. **VARIATION IN QUANTITIES OF WORK:** The work will be generally carried out in accordance with the instructions given at site. The Executive Engineer, Pimpri-Chinchwad Division or his representative reserves right to increase or decrease the quantities of work to be executed or deleted or add any items, part or whole thereof.
27. **ELECTRICAL SAFETY REGULATIONS:** No work shall be carried out on any live equipment. The equipment must be made safe by the Engineer and a permit to work issued before any work is to be carried out.
28. Whenever any recovery towards losses/damages/shortages etc. is applicable the same shall be recovered from your bill, as assessed by the Engineer-In-Charge.
29. **COMPENSATION:** If any accident occurs to any of your worker/your Supervisor/or outsiders in carrying of the work will be on your account. The Company will not be responsible for such accident/ compensation payment etc.
30. **IDLE LABOUR HOURS:** In case of suspension of work, or delay in work due to any reason or stay order of the Court of Law no compensation will be paid by the Company for idle labours /idle machinery etc., during the period.
31. **INCOME TAX & WORK CONTRACT TAX:** Income Tax & Work Contract Tax (if applicable) will be deducted from the contractor's bill.
32. All other Standard Terms and conditions prescribed by M.S.E.T.C.L., regarding supply and Work, which are not stated here, are also applicable to this contract.
33. **JURISDICTION:** All disputes, differences related to the tender contract shall be subject to the exclusive jurisdiction of Pune District Court.
34. **QUALITY OF WORK:** Quality of work to be carried out should be strictly confirmed to our specification, otherwise it will be rejected and contractor has to redone the same at his cost and risk only.
35. The work carried out by the contractor if found defective due to bad workmanship, that should be redone by contractor free of cost, if reported.
36. The prior permission from the concerned Engineer-in-charge is to be taken by the Contractor before starting the work.
37. **EXTENSION IN ORDER:** The MSETCL may give extension for additional 50% work for which the tenderer should agree to work at the same rates, terms & conditions of the parent order.
38. **SUB- LETTING OF CONTRACT:** The contract or any part thereof shall not be assigned, transferred, or sublet without the prior written permission of the undersigned. Even if such permission is granted, it shall be responsibility of the principal contractor to whom the work order was originally issued to execute the works as per the terms of the contract.
39. **FORCE MAJEURE:** Only the following conditions shall be considered for the purpose of this clause.
  - a. Natural Phenomenon such as floods, Draughts, Earthquakes, Epidemics etc
  - b. Acts of any Government, Domestic or Foreign such as war (declared or undeclared) Priorities, Guarantees Embargoes etc.
  - c. The party affected by 'Force Measure' shall within 15 days of the occurrence of such a cause, notify the MSETCL in writing with sufficient documentary proof
40. The provision made in various Acts in force applicable to this contract is obligatory on the Contractor while executing the work.

41. The contractor shall always keep and maintain in order, First Aid Box as a safety measure for the labours.
42. If required you may visit our site before submitting bid to online E-Tender.
43. **SRM Deviation:** If any document is not attached by bidder/ not readable & if required same can be called through SRM deviation only.
44. **DUE DATE OF TENDER :** All the tenders received up to the due date and time will be opened as far as possible on the specified date and time. In case of urgency of work on the specified date or any connectivity & website related problems, same will be opened on next working day.
