- 2) Scope of work covers activities mentioned in SCHEDULE 'A'.
- 3) Vehicle should be of SUMO Jeep type and give minimum average of 12 km per liter (In Words Twelve Kilometer per liter) otherwise recovery will be made for excess fuel consumption.
- 4) The documents like valid insurance, vehicle fitness certificate, vehicle registration, vehicle permit etc. should be submitted along with the quotations.
- 5) All the liabilities against statutory provisions and loss/damage due to accident/theft etc. will be the responsibility of the vehicle owner.
- 6) The vehicle should be registered as a public service vehicle and is also covered by valid contract carriage permit.
- 7) Vehicle with License holder Driver shall be ready at disposal of The Additional Executive Engineer (Testing) 765kV R.S. Division, Ektuni, MSETCL on all days for 24 Hrs.
- 8) Alternative arrangement should be provided when the vehicle is under breakdown/repairs, alternative vehicle shall be hired and expenses of the same shall be recovered from you.
- 9) Per day rate should be mentioned in the quotation. Taxes if any should be mentioned separately.
