'TERMS & CONDITIONS'

- 1. The terms and conditions mentioned in the 'Works and Contract Book-let are applicable and copies of same can be purchased by the Contractor (s) on payment of Rs. 50.00 from the office.
- 2. The work shall have to be completed in all respect within a period of **15 days** from the date issue of work order, failing which the Contractor will be liable to pay compensation / penalty at Half percent per week maximum up to 10% of the value of the work order.
- 3. The rates quoted by the Contractors shall include:
 - i. All tools and plants required for carrying out the job.
 - ii. All labour charges required to execute the job.
 - iii. All temporary works required to complete the work including transportation of all required material to site.
- 4. The Company shall supply no material. All materials are required to be procured by the Contractor.
- 5. The work shall have to be carried out as per the 'Standard Specifications' and with best workmanship like manner and to the entire satisfaction of the Engineer-in-charge.
- 6. The Contractor shall be responsible for all accidents occurred / damages caused during the execution of the work He shall have to make good of the same at his own cost as directed.
- 7. The Contractor shall be responsible to abide all prevailing labour laws including the Workman Compensation Act.
- 8. The successful Contractor shall have to pay Security Deposit amounting to Rs. 15000/- and will be refunded after the completion and clearance of site.
- 9. The quantities in the Schedule 'B' are approximate only and liable for variation.
- 10. The right to reject any or all quotations without assigning any reasons is reserved.

- 11. Any clarification pertaining to work shall be had from the undersigned before submitting the quotation.
- 12. The estimated cost of the work of dismantling is **Rs. 3,13,859.00** /- & the amount for the scrap material is Rs. 3,29,274.00. The different is Rs. 15415.00 which have to deposit towards the cost of scrap material by the contractor. It is totally the responsibility of the contractor to dispose of the unusable / scrap material. After the work agency should clean and level the respective area/site and hand over to MSETCL
- 13. The Contractor shall have to pay Earnest Money Deposit (**E. M. D**) of **Rs. 3140/-** along with the quotation in the form of D. D./ cash in favour of E.E.(Civil), EHV CCCM Dn. Amravati.
