IT IS TO INFORM YOU THAT THIS OFFICE SRM TENDER Rfx No. 7000013466, for the Work of Overhauling of 245/145KV Siemens-Make Circuit Breakers with providing & fixing of required Circuit Breakers spares at various EHV S/Stns under EHV O&M Division, Sangli HEREWITH AMENDED AS BELOW

1. PAYMENT TERMS: -

- i. 60% payment for supply of spares will be made against G.R. from stores, payment will be paid after submission of bills in reasonable time. Out of balance 40%, 20% will be released after successive commissioning of respective CB & remaining 20% will be released after successfully completion of work order.
- ii. Running Account bills for service charges will be paid against completion of particular job subject to completion of work of minimum Rs.5.00 Lakhs.
- iii. The bills in triplicate, advance stamp receipt, along with the certificate from the Engineer-in-charge for having completed the work satisfactorily and all relevant reports must be submitted to the concerned Executive Engineer.

2. PENALTY FOR LATE EXECUTION OF WORK: -

- a) **Supply:** If the material is not supplied in 45 days after receiving work order the contractor shall be liable to pay penalty @ rate 1 % of total amount of supply portion per delayed week.
- **b)** Service: If the work is not completed as per Schedule in specified time, the contractor shall be liable to pay penalty @ rate 1% of total amount of service portion per delayed outage day (Non-outage days will not be considered).
- c) If outage is not started as per planning due to non-reporting of the agency the contractor shall be liable to pay penalty @ 1% of total amount of Service Portion of per instant / occasion.
- **d**) Total penalty is limited to 10% work order amount including taxes.
