TERMS AND CONDITIONS OF CONTRACT

1. Qualifying Conditions:-

- a) Proof of registration of firm / agency under Bombay Shop and Establishment Act.
- b) Copy of GST Registration.
- c) PAN Card Copy
- d) It is essential for contractors to have valid License to sell, stock Or Exhibit for Sale or distribution of insecticides or pesticides of Govt. of Maharashtra.
- e) Registration under EPF and latest paid EPF challan.
- f) Valid Workmen Compensation Policy.
- g) Undertaking / Labour Contract License for the above work.
- h) Experience certificate of similar type of work done (only Experience Certificate will consider don't attach work orders as Experience)

3. OFFER SHOULD BE SUBMITTED IN ONE BID:

This one bid contain the rates quoted by you as per the schedule A and each page of this enquiry with seal and signature in blue ink with all the required documents for qualifying conditions as above.

4. SCOPE OF WORK:-

- a) Cutting and Removal of Grass & Shrub with Initial chemical treatment comprising of grass removal & treating the swithyard with 41% Glycel for pest control method and disposing the removed grass, i.e. bluent or as directed by Engineer incharge as per site condition at, Major Store Osmanabad
- b) Continuous maintenance of swithyard for one calender years by applying different concentrated chemicals by pest control method to this , agency has to attend for maintence work as and when there is call from Executive Engineer or concerned Engineer from Major Store Osmanabad. Ultimately yard should be clean & free from growth of any type of grass weed & disposing the removed grass as directed by Engineer at Major Store Osmanabad.

5. **Security deposit:** - The Bidder whose enquiry will be accepted and termed thereafter as a contractor shall have to pay the security deposit @ 10% of the contract value within 10 days from the receipt of the letter of indent of detailed order with letter of acceptance of the contract. The amount of S.D. should be paid in Cash / D.D. in favor of "**Executive Engineer Major Store Aurangabad**" Payable at Aurangabad.

6. **EXECUTION OF WORK:** - The successful Bidder, hereafter referred to as the contractor shall execute order immediately as per Schedule A enclosed within 15 Days from the date of handing over the Site.

7. **PENALTY FOR LATE EXECUTION OF THE WORK:** - If the work is not completed as per the Schedule in specified time, the contractor shall be liable to pay penalty at 1% per day subject to a maximum of 10% of the value of the order.

8. **SUBMISSION OF BILLS:** - The bill for the work as per Schedule A should be submitted to The Executive Engineer, Major Store, Osmanabad after satisfactory completion of the work. The 100% payment will be made by Major Store Aurangabad after receipt of bills duly recorded in M.B. by concerned Engineer in-charge. The payment will be made as per availability of funds.

9. In case of any dispute whatsoever, regarding interpretation of the terms and conditions or quality/quantity etc: the decision of the Executive Engineer, MSETCL, Major Store Osmanabad will be final and binding on the contractor.

10. The provision made in various Acts in force applicable to this contract is obligatory on the Contractor while Executing the work.




