TERMS AND CONDITIONS

- 1) SCOPE OF WORK: Providing and fixing of spare parts of standard/reputed make and required specification for Videocon Make Air conditioners (4 Nos.) at 132 KV Pandharkawda S/stn as per Schedule "A".
- 2) RATES: Should stand firm at least for one month, otherwise maximum percentage in the rates should be stated.
- 3) TAXES: Taxes which are applicable for the said work should be clearly mentioned in the quotation. Documents viz. PAN registration numbers, GST registration, Shop & establishment regn. Cert. etc. should be enclosed along with the quotation. Taxes will be deducted as per government rule
- 4) **PERIOD OF CONTRACT:** The work as per SCHEDULE "A" shall be completed within three month from the date of order by the successful bidder
- 5) WORK COMPLETION PERIOD: The work shall be attended within 24Hrs after giving the call and completed within minimum time after handing over of site/work.
- 6) QUALITY OF MATERIAL: The material offered shall be of good quality and strictly confirm to the specification.

- 7) **PENAULTY**: If you fail to execute the work within stipulated period mentioned, penalty @ of 1/2% per week maximum up to 10% shall be imposed on the cost of the work.
- 8) SECURITY DEPOSIT: The successful bidder will have to pay security deposit amounting to 10% of the total value of order by cash/BG/FDR. The same will be refunded without any interest after satisfactorily completion of work and finalization of bills.

- **WORKMANSHIP:** Your workmanship shall be best. The work should be of best quality & should be without defects and strictly as per norms of company. If found substandard, the same will have to be carried out by you as per requirement of authority concerned.
- 14) STATUTORY OBLIGATIONS: The Company will not be responsible for any mishap /accidents/compensation if any to your workmen etc. during and after execution of work. The same shall be dealt by you as per workman compensation act, 1948, and time to time amendments thereto. All applicable statutory rules, laws will have to be observed by you and in any case breach thereof on your part, MSETCL will not be responsible for any consequences.
- 15) MSETCL RULES: In addition to above, the contract will be governed by General terms and conditions mentioned in MSETCL booklet of contract terms and conditions.
- **DEDUCTIONS:** Income Tax, labour cess & GST TDS will be recovered as per rule from your bills as per rule.
- 17) LOSS/DAMAGES: For damages if caused to company's property during execution of work shall be at contractors account and will be recovered from your SD/Bills.
- **TEST CERTIFICATE/JOINT WORK COMPLETION REPORT**: The work completion report shall be prepared and jointly signed by the concerned SDO and contractor's representative after the complete execution of work. Any observation/comments shall be mentioned on the reports.

The date of joint work completion report shall be considered as the start date for the guarantee period.
