#### Enquiry

**Sub:** Enquiry for the work of Service of SF6 gas recovery from low pressure gas cylinder & collection of it in single cylinder & mobilization charges of SF6 gas handling plant, under EHV O&M Dn., Ratnagiri.

Please quote your lowest Rates for the said work on contract daily basis. Sealed and super scribed quotations are invited by the undersigned for above work. Quotation must reach to this office on or before 13.11.2019.

## **Terms and Conditions:**

1) **Prices**: The rates are accepted as per schedule 'A' with work at various EHV substations under EHV O&M Division Ratnagiri.

#### 2) Qualifying conditions:

- a) Valid electrical contractor certificate.
- b) Order copies along with performance certificate against same type of work issued by authority not below the rank of Executive Engineer.
- c) Valid GST registration certificate.
- d) Copy of PAN card.
- 3) **Taxes**: Rates should be quoted inclusive of all taxes & cess and the taxes will be deducted as per prevailing rate of Govt. rule.
- 4) **Scope of work**: The work is for Service of SF6 gas recovery from low pressure gas cylinder & collection of it in single cylinder & mobilization charges of SF6 gas handling plant as per Schedule 'A'. Tests of SF6 gas confirm to IEC: 376 & IS-13072 before recovery from low pressure cylinder & after collection of gas in single cylinder to be carried out & mentioned in service report. The spares utilized for the work should be of genuine and good quality shall confirms to ANSI:B571 or BS:341 part 1 or IS: 3224. The old material should be handed over to the S/s In-charge. The work should be carry out under the supervision of concern S/s In-charge as per IEC 60480 & IEC 61634. All required T&P/manpower should be arranged by contractor.
- 5) **Contractor's Employees**: The contractor shall employ and provide onsite only such employees as are skilled and experienced for execution of works. He shall also make suitable arrangement for the accommodation of his employees.
- 6) **Damages to Persons and property**: The contractor shall indemnify the Board against any losses and claim in respect of injuries or damage to any persons, material or physical damage to any property whatsoever, which may arise out of or in consequence of the work.
- 7) **Site clearance**: On completion of the works, the contractor shall clear away and remove from the site all surplus material, rubbish and temporary work of any kind. The site should be kept clean.
- 8) **Insurance**: The insurance of your labour at your cost only, if fail the compensation/ claims arrears will be at your risk.

- 9) **Security Deposit**: The contractor should pay security deposit at the rate of 5% of the value within 7 days from the date of receipt of order.
- 10) **Monitoring of order amount**: Contractor has to monitor work order amount. If the work exceeds beyond work order amount, excess amount will not be paid at any cost.
- 11) **Accident**: Any accident to your labour while executing the work, any loss/ damage to MSETCL's property during execution of work, will be on your account and you will have to make it good at your cost.
- 12) **Validity of order**: The order should be valid for period of 180 days from the date of issue of order or exhausting the order amount whichever will be earlier.
- 13) **Agreement Bond**: The contractor will have to execute an Indemnity Bond on stamp paper of **Rs.500/-** at his own cost if order is placed.
- 14) **Completion period**: The work should be completed in 7 days after handing over of site to you. The contractor may visit the site before quoting the rates.
- 15) **Bills**: The bills in triplicate should be submitted to the office of the Executive Engineer, EHV O&M Dn., Ratnagiri after satisfactory completion of work. The bills will be processed for payment after MB recording of the same by concern S/s In-charge. Please quote your GST No. on your bill.
- 16) Payment Terms: 100% payment will be made against submission of following documents.
  - 1) Bill in triplicate, 2) Guarantee certificate, 3) Joint Measurement Certificate,
  - 4) Security Deposit, 5) Agreement Bond.
- 17) **Tax deduction at source**: In accordance with I.T. Act 1961, I.T. will be deducted at source at the prevailing rates from the bills. Similarly any other tax deductible at source (such as Cess, WCT), if applicable to this particular contract, as per statutory (laid down by Central or State Government), will also be deducted from the bills at the prevailing rates.
- 18) **Penalty**: If contractor fail to complete the works in the stipulated time period, he shall be liable to pay to the Company the sum equal to ½ % of the contract sum (for the delayed portion of work) per day delayed, subject to a maximum of 10% of order value.
  - Further, if the contractor, after having accepted the contract, is unable to execute the same in full, MSETCL reserves the right to get it executed either departmentally or by any other agency, the cost & risk of which shall be borne by the contractor.
- 19) **Guarantee**: You will have to give the guarantee of one year for workmanship & material from the date of work completion and guarantee should be submitted alongwith the bills. For any defects in workmanship you will have to give free service within 7 days from the date of intimation within guarantee period including providing and fixing of material.
- 20) **Termination of Contract**: The undersigned reserves the right to cancel the contract, after giving due notice to the contractor, in the event of the breach of contract in any respect.
- 21) **Applicability of General Conditions of Contract**: Notwithstanding anything stated here in the Company's General Conditions of Contract shall be applicable to the contract, as far as they are applicable, in respect of this order.
- 22) **Jurisdiction**: All disputes, differences related to the tender / contract shall be subject to the exclusive jurisdiction of Ratnagiri District Court.
- 23) The MSETCL's general terms & conditions of work contract are applicable to this order. Thanking You.
