- 3) **Quoted Rates:** The rates quoted are including of all taxes, charges, labour cess or any other local charges etc. Please mention GST separately.
- 4) **Security Deposit:** The successful bidder will have to pay an amount equivalent to <u>5 (Five) %</u> of Contract value towards S.D. at Executive Engineer, EHV (O&M) Division, Dhule within 15 days from the date of receipt of work order.
