**TERMS AND CONDITIONS:-**

1. The rate shall be quoted on firm quotation basis.
2. The rates should be quoted excluding / including of taxes. The taxes if any should be quoted extra.
3. The quotation should be sent under sealed cover duly super scribed as **QUOTATION FOR Supply & Erection of spares to yard lighting fixtures at 400 kV R S Kumbhargaoon, Nanded.**

4. Your quotation should reach this office **on or before 13.12.2019 up to 17:00 hrs** and the same will be Opened on the same day, if possible.
5. Documents required:- The rate offer must be accompanied with the following documents duly attested & signed by the Agency.
  - A. Valid proof of valid electrical contractor license.
  - B. Valid Proof of registration under GST.
  - C. Valid Shop Act registration.
  - D. Valid proof of EPF registration.
6. Quotation received after due date will not be considered. This office is not responsible for any postal delay.
7. Before quoting rates, agency if needed may inspect the site.
8. Income tax & Labour Cess will be recovered as per prevailing rules.
9. The rates offer submitted by you should be valid for at least 90 days from the last date of receipt of quotation.



10. 100 % payment will be made after receipt of material in good condition at 400 kV S/s Maint. Unit K'gaon, Nanded & after receipt of bills in triplicate (Indicating PAN No., GST Reg. No.) to this office. The payment against this contract will be effected by Executive Engineer, 400 kV R S Division Kumbhargaoon, Nanded within reasonable time as per funds availability.
11. Please quote your PAN, GST No. in the quotation.
12. The T&P for the work will be arranged by the agency i.e. no T&P provide by MSETCL for the above work.
13. **Scope of work:** - The Supply & Erection of spares to yard lighting fixtures is required as per following procedure.
  - A. Removing of the fixtures from high mast tower and re-fixing after replacement.
  - B. Replacing the spares, checking up wiring loose connections, cleaning of reflectors, inner surface of glass and overall Maintenance so as to give optimum illumination.
  - C. The material should be of Standard make i.e. **Bajaj / Philips/ Crompton Greaves or as directed by Maint. Unit Incharge** is to be provided by agency to fixtures. The bidder should visit the site and get himself familiarized with the site and equipment required before start of work and get the permission in written from Concern Executive Engineer to start the work.
  - D. The contractor should handover the replaced material/scrap to the Maint. In-charge before leaving the site.
14. **Work completion Period:-** After receipt of work order for Supply & Erection of spares to yard lighting fixtures at 400 kV R S Kumbhargaoon, Nanded the work shall be completed within **30 days** otherwise penalty @ 1% per week subject to max.10% of the order amount will be levied at the discretion of the Competent Authority.


