- 8. Certificate of Valid shop act & establishment registration or NOC of Grampanchayat as applicable.

- **2.** If validity of any license/certificate expires during order period, you will have to renew the same & submit the copy to this office.
- **3.** Quotations with incomplete details submitted without sealing or superscribing not submitted in prescribed format etc are liable to reject. Offer on fax or e-mail will not be accepted. This office will not be responsible for delay in postal transit. The agency should not submit 'conditional quotation'. Such conditional offer shall be liable for rejection.

Executive Engineer, Line Maint.S/Dn-II,Pune. The running of hired vehicle will be the area of operation under Line Maint.S/Dn-II,Pune.
- **6. Driver:** Vehicle will be driven by your driver who shall be well behaved, neatly dressed with good habits. He should scrupulously (carefully) follow all rules & regulation of RTO & traffic police. He must possess valid driving licence.
