TERMS AND CONDITIONS:

1. Rates should stand firm at least for the period mentioned above. The vehicle shall be in good condition. The tyres should not be worn out. The condition of the vehicle will be the criteria for selection of vehicle irrespective of the rates quoted.
2. GST will be paid extra (exclusive), if GST registered vendor.
3. The date of manufacture of vehicle and RTO registration of vehicle should be after dt. 01.01.2015.
4. Attested photocopies of the vehicle documents such as RC Book, TC book, valid insurance certificate for the contract period, PUC certificate, taxi permit of vehicle, Driver's License, Fitness certificate of the vehicle, RTO tax receipt for current year, Registration certificate/ Route permit of transport contractor, Photo ID proof of vehicle owner, GST Registration No. (If applicable), etc. will have to be submitted to the office along with the quotation submitted.
5. The undersigned reserves the right of verification of original documents at any time during the contract period.
6. Please mention the consumption average of the vehicle with A.C clearly km/litre of diesel.
7. The general working time is from 10.00 am to 05.30 pm. This time may vary as per the working conditions and as directed by the authority.
8. The vehicle will be required for almost all working days as per calendar month and as and when required in emergency as well as on holiday also.
9. No overtime will be paid for excess working hours, if utilized for any day and no halting charges will be paid extra.
10. The vehicle will have to be stationed at the place indicated by the Superintending Engineer, EHV O&M Circle, Amravati.
11. The Engine oil /lubricants or other items will not be provided by the Company.
12. R.T.O. Or Police Department and other legal liabilities on account of accident, etc. will be at owner's account.
13. Initially the agency will have to supply the Diesel for vehicle. The amount expended on diesel only shall be reimbursed to the owner in monthly bill with average of vehicle - 14 Km/Ltr. with A.C and as 18 Km/Ltr. without A.C.
14. The cost on account of maintenance/ repairs, driver wages, allowances and vehicle taxes etc. if any shall have to be borne by the Agency.
15. The successful agency will have to pay the security deposit @ 5% of the order value within seven days from the date of receipt of firm order.

16. Agreement:

As per rules of Maharashtra State Electricity Transmission Company Ltd., successful bidder will have to execute an agreement on Rs 500/- stamp paper in respect of this contract within a period of two weeks from the date of issue of work order. The cost of stamp paper etc. for the agreement shall be borne by the concern agency. No payment shall be made to you under this contract till such time the agreement is executed by you.

16. GENERAL – The undersigned reserves all rights to reject any (or all) quotations, without assigning any reasons.

17. Jurisdiction of this Circle is Amravati, Yavatmal Districts and also the adjacent districts as per requirement.

18. In case of any dispute regarding any clause of the enquiry document the decision of the undersigned will be final and binding on all the bidders.

19. The disputes, if any, under this enquiry shall be subjected to the jurisdiction of the Amravati Court only.
