- 2) Material shall be warranted as per manufacturer warrantee terms.
- 3) Work shall be carried out as per Schedule 'A'
- 4) Rates quoted shall be valid for the period of 90 days from date of opening.
- 5) If registered under SSI the Photostat copy of the registration should be submitted alongwith with the quotation.
- 6) Following documents needs to be submitted along with enquiry
  - 1. Details such as name, address, contact number etc.
  - 2. Valid GST registration certificate.
  - 3. Copy of PAN Card.
  - 4. Shop Act license copy.
- 7) The rates quoted shall be on firm quotation basis.
- 8) The envelope should be super scribed as Supply of single phase welding machine.
- 9) The right to reject any or all the quotations is reserved by the undersigned.
- 10) 100% payment will be effected in reasonable time after receipt of material in good condition.
