- 1) The rates quoted must be exclusive of all taxes and delivery to Executive Engineer 400 KV R.S. Talandge. Taxes should be quoted extra.
- 2) Material shall be warranted as per manufacturer warrantee terms.
- 3) Work shall be carried out as per Schedule 'A'
- 4) Rates quoted shall be valid for the period of 90 days from date of opening.
- 5) If registered under SSI the Photostat copy of the registration should be submitted alongwith with the quotation.
- 6) **Following documents needs to be submitted along with enquiry**
  1. Details such as name, address, contact number etc.
  2. Valid GST registration certificate.
  3. Copy of PAN Card.
  4. Shop Act license copy.
- 7) The rates quoted shall be on firm quotation basis.
- 8) The envelope should be super scribed as Supply of single phase welding machine.
- 9) The right to reject any or all the quotations is reserved by the undersigned.
- 10) 100% payment will be effected in reasonable time after receipt of material in good condition.
- 11) Agency shall pay 10% of order value as **security Deposit**. This Security Deposit will be paid after completion of guarantee/warrantee period.
- 12) Save and Except: Amounts due on account of damages or compensation for default or breach of contract by the contractor in which case instead of deduction of the said amount shall be retained and purchaser shall have the right or lieu on amounts retained or withheld.
