TERMS & CONDITIONS:

- 1. DUE DATE: The quotations, complete in all respects, duly sealed & superscribed should be submitted to this office on or before due dated i.e.30.12.2019 @ 12:00 PM.
- 2. **QUOTED RATES:** The quoted rates should include the cost of driver, all type of maintenance, diesel & insurance etc.
- **3. VALIDITY OF OFFER:** The offer should be valid for our acceptance for a period of 60 days from the due date of opening.
- 4. **EMD**: You have to pay an EMD amount of Rs.5,000/- to this office in the form of Cash/DD. If exempted for paying EMD please submit the documents as per <u>circular No. MSETCL/Director(Ops.)/10812 dt.10.10.2018.</u>

As per the circular, it is state that "The registration certificate as submitted by Micro and small enterprises should be valid on the date of submission of bid and the validity of the same should be certified by the Chartered Accountant in practice."

Note: In case, the micro & small enterprise (who have been exempted from payment of EMD/Tender Fee) does not accept the tender being L1, then such micro & small enterprises shall be debarred from the bidding process for all tenders at MSETCL for next 2 years from the date of non-acceptance of L1 bis and this is to be clearly mentioned in all tenders.

- 5. **SECURITY DEPOSIT**: Security deposit @ of 5% of order value should be paid on receipt of order within **Seven days**.
- 6. **PENALTY FOR DEFAULT**: The vehicle remain absent for any 1 day then 10% penalty rate will impose in the working day rate. In case the absence exceeds more than 15 days notice to terminate the contract will be issued. If service is not resume within the notice period the said contract will be terminated without any further information, forfeiting the security deposit.

Payment will be made on the basis of actual working day as per the record of the vehicle maintain and therefore, bill in triplicate must be submitted. The Executive Engineer, EHV Projects Division, Kalwa reserves the rites of imposing penalty as indicated above. A vehicle is not required on a particular day it will be intimated in advance to the driver and such absence will be without payment.

- 7. **DRIVER**: The drivers should have valid driving licence. The driver should be polite in behaviour. He should be on duty with neat & clean clothes. He should of obedient & free from any kind of bad habits. In case any thing wrong is found with the driver vehicle shall be immediately discontinued.

- 6. Copy of Pan card.
- 7. Copy of Gumastha Licence/Registration certificate under Bombay shop & establishment Act.
- 9. Vehicle fitness certificate from RTO.
- 10. Payment of EMD as per revise circulars.
- 11. Consent letter of vehicle owner for providing vehicle on hired basis to MSETCL if the vehicle is not belong to the contractor.
- 12. Partnership Deed document if applicable.

These documents shall always be available with the vehicle.
