TERMS AND CONDITIONS:

The offer should be submitted in two separate sealed envelopes contained in one main envelopes super scribing the subject.

Envelope 1: Should contain associated documents/Certificates/proof of qualifying pre-requisite Broachers attested certificate etc such as,

- a) Copy of valid shop act
- b) Copy of Pan card
- c) Work experience certificate of similar work executed (not below the rank of Executive Engineer)
- d) Valid registration under GST

If validity of any license/certificate expires during order period, you will have to renew the same & submit the copy to this office. Payment will be affected for valid period only

Envelope 2: Price bid documents: This should contain only price bid in given schedule, not in any other format. After verifying full documents /certificated pre-qualification as above in envelope 1,if it is found that ,bidder fulfills the desired prerequisites, envelope 2. will be opened. If the same is not meeting the prerequisites, Envelope 2 shall not open.

Instructions to the Bidders:

1. Quotations with incomplete details submitted without sealing or superscripting not submitted in prescribed format etc are liable to reject. Offer on fax or e-mail will not be accepted. This office will not be responsible for delay in postal transit. The agency should not submit 'conditional quotation' such conditional offer shall be liable for rejection.

2. Discarded to E-enquiry conditions: The Company reserves the right with itself to reject the E-enquiry.

3. The decision of the Executive Engineer, EHV O&M Division I, Pune about the interpretation of any terms and conditions of this E-enquiry specification will be final & any other interpretation from the bidder or agency will not be allowed.

4. **Security Deposit:** The contractor has to remit, Security Deposit @ of 5% of the total value of the order in this office in by D.D./ B.G./ fixed deposit in nationalized or scheduled bank after acceptance of the work order and before starting the execution of the work as per work order. The amount of the Security Deposit will be refunded to you after successful completion of the Guarantee Period & if applied within six months from the date of completion of the work as per work order as well as after obtaining no dues certificate / No objection Certificate from all concerned SSI .

5. **Agreement:-**The agreement should be executed on Rs.500/- Bond paper & cost of agreement to be borne by agency.

6. **Work completion Period:** The work should be completed within 15 days from the date of issue of work order.

7. **Supervision of Work:-**The work shall be under the supervision of the Executive Engineer, EHV O&M Division-I, Pune or his representative.

8. The T&P/ labour/ machinery/ equipment/ material required for the work shall be on your account.

9. **Penalty:** In case of failure to complete the work in stipulated time as mentioned above, you will be liable to pay penalty at rate of 1/2% per day subject to maximum limit of 10% of the total values of the order.
