The Maharashtra State Electricity Transmission Company Limited Pune, here in after referred as the "Owner" (MSETCL) INVITES online bids from eligible Indian bidders for Supply 3 nos of Digital Multi meters and 5 nos. of Clamp on meters at Testing Dn., Pune as per Schedule 'A' and Terms & Conditions on or before 06.02.2020, 15.30 Hrs.

- **a) Work:** Supply 3 nos of Digital Multi meters and 5 nos. of Clamp on meters at Testing Dn., Pune.
- b) Estimated cost: Rs. 99,121/- Including all taxes.

Your offer should be submitted in two separate bids – 1. Technical Bid & 2. Commercial Bid

Submission of bid

Two bid systems should be followed for submitting the offer. Uploading of required documents shall be done on MSETCL's SRM E-tender website https://srmetender.mahatransco.in/

1. <u>Technical Bid (Part-I)</u> - This should contain following documents certificate/ as a proof of qualifying pre-requisites, broachers, attested certificates etc.

B. Commercial bid (Part-II):-

- Techno-commercial bid will be opened online for all received bids. After verifying the all documents /certificates submitted in techno commercial bid for prequalification as mentioned above, if it is found that, the bidder fulfills the desired prerequisites; the price bid will be opened online. If the same is not found to be meeting the prerequisite, the commercial bid shall not be opened. Offers with incomplete details or not submitted in prescribed forms etc. are liable to reject.
- This office reserves all the rights to reject any or all tenders without assigning any reasons thereof.

- The technical documents should be uploaded in the technical bid & commercial documents /offer/price bid should be uploaded separately, in case both technical & commercial bid are uploaded in one file wrongly, the offer will be rejected.
- The offer shall be valid up to 120 days from the date of opening of the Enquiry.
- The estimated rates given by this office are inclusive of taxes. However, the bidder should quote rates exclusive of all Taxes. The taxes should be quoted separately.

TERMS AND CONDITIONS:

- **1. <u>Scope Of Work:</u>** Supply 3 nos of Digital Multi meters and 5 nos. of Clamp on meters at Testing Dn., Pune as per Schedule A enclosed herewith
- 2. <u>Period Of Contract</u>: The Period of contract will be one month (30 days) from date of issue of work order.
- **3.** <u>Security Deposit</u>: You have to remit, <u>before execution of order</u>, Security Deposit @ of 10 % of the total value of the order i.e. Rs. 9,912/- in this office in Cash/ by D.D. / B.G. / fixed deposit in nationalized or scheduled bank after acceptance of this order and amount of S.D. shall be refunded to you after successful completion of work if applied within six months from the date of completion of order along with no dues certificate from all contract basis employees.
- **4.** <u>Validity Of Enquiry</u>: Enquiry shall remain open for acceptance for a period of 7 days from the date on which it is due for submission. During this period, no bidder shall be allowed to withdraw his tender. Any such withdrawal during the said period will entitle the forfeiture of the earnest money deposited by the bidder. As such the offer submitted by the bidder must have a validity of minimum 90 days from the last date of submission of offer.
- **5.** <u>Acceptance Of Tender</u>: The Company does not bind itself to accept the lowest or any bid neither will any reason be assigned for the rejection of any bid. It is also not binding on the Company to disclose any analysis report on tender.
- **6.** <u>Discarded To Tender Conditions</u>: The Company reserves to itself the right to reject the tender.
- 7. Work Completion Period: Work should be completed within 2 months from the date of issue of work order
- **8.** Execution Of Work: Work will have to be executed as per the instruction of Executive Engineer or his representative.
- <u>09.Signing Of Contract</u>: The contractor shall enter into an agreement of Rs. 500/- with the MSETCL within 30 days from the date of receipt of the work order. Until the agreement is executed, the MSETCL will not be liable to pay, nor shall the contractor be entitled to claim amount due or payable under the contract. The necessary stamp duty for the agreement shall be borne by the contractor.
- **10.** <u>Guarantee:</u> Guarantee of material i.e. Multi meters and Clamp meters supplied to MSETCL should be provided. Any defects developed during guarantee period should be rectified at the cost of contractor.
- 11. <u>Penalty</u>: If the work is not completed within stipulated period the penalty @ ½% per week as applicable subject to maximum 10% of the order value of work, will be levied. Loss to MSETCL property or equivalent etc. due to your negligence will be penalized & will be recovered from the bill.
- **12.Failure Of Execution Of The Work:** For failure to execute the work as per given Schedule "A" against the order in full, within the stipulated period, the Company shall be at liberty, without further notice or reminder to the contractor to get the same work done on account of and at the risk of the contractor and the prefer a claim for the difference in price and for all expense whatsoever incurred in getting the said work done and the same shall be recovered from any payment due to the Contractor from bills or deposit.

- 13. In case the work is not executed partly or fully the balance work will be got carried out from some other agency even at higher rate and difference in cost will be recovered from your pending bill with the Company or Security Deposit will be forfeited in addition to above.
- **14.** <u>Acceptances Of Contract Work:</u> The work against this contract will be subject to the approval of the Executive Engineer, Testing Division Pune. He is at liberty to reject any or the whole without assigning any reason and his decision in respect of such rejection will be final.
- **15.** <u>Submission Of Tax Invoice</u>: The tax invoice should be submitted to the Office of Executive Engineer Testing Division Pune as per Schedule 'A'. After receipt of tax invoice, payment will be effected accordingly subject to availability of funds.
- **16.** Other Conditions Of Tender And Contractor: The tenders and orders / contract placed against this specification shall be governed by the Company's General Conditions of contract, the bidder is deemed to be fully aware of these conditions and ignorance thereof shall not exempt him from his liability to abide by these conditions.
- **17.** In case of any dispute whatsoever, regarding interpretation of the terms and conditions, or quality, the decision of the Executive Engineer, Testing Division Pune will be final and binding on the contractor.
- **18. Income Tax:** Income Tax will be deducted from the contractor's bill.
- **19.** All other Standard Terms and conditions prescribed by M.S.E.T.C.L., regarding supply and work, which are not stated here, are also applicable to this contract.
- **20.** <u>Jurisdiction</u>: All disputes, differences related to the tender contract shall be subject to the exclusive jurisdiction of Pune District Court.
- 21. **Quality Of Work:** Quality of material supplied should be strictly confirmed to our specification, otherwise it will be rejected and contractor has to redone the same at his cost and risk only.
- **22**. The work carried out by the contractor if found defective due to bad workmanship, that should be redone by contractor free of cost, if reported.
- **23.** The provision made in various Acts in force applicable to this contract is obligatory on the Contractor while executing the work.
