ANNEXURE (W)

GENERAL TERMS AND CONDITIONS

1) SUPERVISION OF THE WORKS.

The works shall be under the overall supervision, concerned S/S Incharge /Line incharge and shall be subject to the approval of the Executive Engineer concerned, or his designated representative. The material to be used in execution of the works must be got approved from him in advance, and only the approved material should be used. All the material should be kept in the custody of the contractor till the completion of the work. The contractor shall obtain a certificate from the Executive Engineer for having executed the works satisfactorily, and also having returned the balance and replaced material if provided by MSETCL

2) QUANTITIES.

The quantities indicated in the Schedule 'A' are approximate, and only indicative. The actual quantities may vary. The payment will be done for the actual quantity of work done.

3) CONTRACTOR'S EMPLOYEES.

The contractor shall employ and provide on site only such employees who are skilled and experienced for execution and supervision of works. He shall also make suitable arrangement for the accommodation of his employees.

4) DAMAGE TO PERSONS AND PROPERTY.

The contractor shall indemnify the Board against any losses and claim in respect of injuries or damage to any persons, material or physical damage to any property whatsoever, which may arise out of or in consequence of the execution of the work. If any damage/loss occurs to the company during execution should be recovered from you.

SITE CLEARANCE. 5)

On completion of the works, the contractor shall clear away and remove from the site all surplus materials, rubbish and temporary work of any kind. The site should be kept clean.

SUB-LETTING OF CONTRACT. 6)

The contract or any part there of shall not be assigned, transferred, or sub-let without the prior written permission of the undersigned. Even if such permission is granted, it shall be the responsibility of the principal contractor to whom the work order was originally issued, to execute the works as per the terms of the contract.

The contractor should pay security deposit at the rate of 5 % of the value of the order. Security Deposit is payable by D.D./ Bank Guarantee from a nationalized/scheduled Bank. The S.D. will be refunded after satisfactory Completion of the work.

Labour cess @1%, TDS and GST as applicable will be recovered from your bill. 8)

PAYMENT TERMS. 9)

i) The bills in triplicate, advance stamp receipt, along with the certificate from the Engineer-In-Charge for having completed the work satisfactorily, having returned the balance and the replaced material, and all relevant test reports must be submitted to the concerned Executive Engineer/ Engineer-In-Charge of the work.

ii)100% payment will be made against submission of bills if no guarantee is prescribed in the

iii)Running Account bills will be paid against completion of one or more particular jobs.

10) GUARANTEE:- The complete work (material and workmanship) should be guaranteed for 12 months form the date of completion of the work.. Any defective work observed during the guarantee period should be rectified by you free of cost immediately.

TAX DEDUCTION AT SOURCE :-

A)In accordance with I.T. Act. 1961, I.T. will be deducted at source at the prevailing rates from the bills. Please furnish the PAN number. And GST No. in your bill.

Similarly any other tax deductible at source, if applicable to this particular contract, as per statutory provisions (laid down by Central or State Government.) will also be deducted from the bills at the prevailing rates.

TDS Certificate will not be issued unless the furnish of registration under I.T.

12) LIQUIDATED DAMAGES FOR DELAY IN EXECUTION.

Should the contractor fail to complete the works in the stipulated time period, he shall be liable to pay to the Company, the sum equal to one percent of the contract sum (for the delayed portion of work) per day delayed, subject to a maximum of ten percent as liquidated damages, and subject further to Force Majeure conditions.

Further, if the contractor, after having accepted the contract, is unable to execute the same in full, the Board reserves the right to get it executed either departmentally or by any other agency, the cost & risk of which shall be borne by the contractor.

13) TERMINATION OF CONTRACT.

The undersigned reserves the right to cancel the contract, after giving due notice to the contractor, in the even of the breach of contract in any respect.

14) APPLICABILITY OF GENERAL CONDITIONS OF CONTRACT.

Notwithstanding anything stated herein, the Company's General Conditions of Contract shall be applicable to the contract, as far as they are applicable, in respect of this order.

15) JURISDICATION.

All disputes, differences related to the tender/ Contract shall be subject to the exclusive jurisdiction of Raigad District Courts/ Mumbai H.C.
