The quotation may please be submitted in a sealed envelope superscripted "Quotation for the work of providing & installation of CCTV surveillance & Remote Monitoring & Recording system in the premises of New Administrative building EHV PC (O&M) Zone, Amravati." and submit to this office by hand delivery on or before 11.02.2020 upto 13:00 Hrs. Quotation will be opened on the same day if possible.

The rates quoted shall be inclusive of all taxes. Anticipating your early response.

TERMS AND CONDITION.

1. **Rates :-** Rates quoted shall stand firm at least for two months.
2. **Taxes :-** Rate should be quoted inclusive of all taxes.
3. **Pan Card :-** I.T.PAN Card Number and Xerox copy of the same. GST Registration Number should be enclosed along with quotation.
4. Any damage to any properties during execution of work shall be at the contractor account and cost of such damage will be recovered from him.
5. **Delivery period:-** The work shall be executed within 45 days from the date of issue of order.
6. **Payment:** - The payment of the bill will be made within reasonable time after receipt of bill to this office.
7. **Penalty :-** If the work is not executed within stipulated period, the penalty @ 1/2% per week on delayed portion maximum to 10% of order amount shall be levied.
8. **Income tax & WCT:** - Income tax & WCT will be deducted as per prevailing rules.
9. The quotation shall be filled in by responsible and authorized person in all respect. The authorization of the person signing the bid shall be submitted and those should be authorized by the person not below the rank of the Proprietor of the bidder. The quotations will not be treated valid unless signed.
10. Right to reject or accept any or all quotations without assigning any reasons thereof is reserved by the undersigned.
11. In case of any dispute regarding any clause of the Enquiry document the decision of the undersigned will be final and binding on all the bidders.

12. The disputes, if any, under this Enquiry shall be subjected to the jurisdiction of the Amravati Court only.
13. **Submission of quotations:-** The quotations shall be submitted in sealed envelope in receipt section of EHV PC (O&M) Zone, Amravati on or before 13:00 Hrs. **11.02.2020** The quotations received after due date will not be entertained. The name of the agency should be written on envelope.
14. **Security Deposit:** - 10% of the value of the order is to be paid as **Security Deposit** by cash at the office of the Superintending Engineer, EHV O&M Circle, Amravati. The Security Deposit can also be paid by Demand Draft/Fixed Deposit/Cash in the name of the Superintending Engineer, EHV O&M Circle, Amravati, within seven days from the date of receipt of this order. The Security Deposit will be returned to the Contractor without any interest after satisfactory completion of work i.e after 12 month from completion period.
15. **QUALITY:** - The quality of the material shall be as per specifications mentioned in Schedule "A".
16. **INSURANCE:-**The contractor shall bear the Transit Insurance of the material. No payment will be done by MSETCL in case of damage to the material during the transportation/loading/unloading. Insurance of the personnel engaged for the work shall be the Contractor's responsibility.
17. An agreement on stamp paper of Rs.500/- will have to be executed to the agency.
18. **General :-** The bidder are also deemed to be fully aware of the company's general Conditions of contract for work, supply of equipment/material and any ignorance of any the condition will not exempt you from liability to abide by the same.
