2. **Nature of work :-** Garden Maintenance of already planted trees, garden and flower beds at 400 KV R.S.(O&M) Dn Lonikand-II S/Stn. As per "Schedule A"
3. **Supervision of work :** - The work shall be supervise by Addl.EE (Maint.) Lonikand -II or his representatives per specification.
