

1) Submission for bids :-

- 3. <u>Supervision of work</u> : The work shall be supervise by Addl.EE (Maint.) Lonikand -II or his representatives per specification.
- 4. The estimated rates given by this office are inclusive of taxes. Hence bidder should quote rates
- inclusive/exclusive of taxes. If bidder quote rate exclusive of tax, then taxes should be quoted separately.Required transportation arrangement of material regarding to work shall be on contractor's account.
- 6. <u>Penalty :-</u>In case of failure to complete the work as per our description, contractor will be liable to pay
 - penalty at rate 1/2% per week of order value subject to maximum 10% of order value.
- 7. Payment will be made at every month within reasonable period by A/c. Payee cheque only after receiving the necessary certificate from engineer In charge regarding satisfactory completion of work. You have to submit the bill in triplicate to this office by mentioning your GST & PAN No. etc.
- 8. The agency should carry out the work in the premises of 400 KV Lonikand –II S/stn under the supervision of Add.EE (M) or his representatives per specification mentioned in Schedule A .
- 9. The contractor shall not be entitled to claim any interest on amount payable to him. The sub contract against the order will not be accepted.
- 10. Contractor should be fully aware of the MSETCL's General Condition for execution of work and same is applicable to this contract also. Any of the condition will not exempt you from your liability to be abiding by the same.
- 11. Statutory taxes will be deducted from bill as applicable

- 15. **Security Deposit**: The bidder will have to pay the security deposit of 5% of the amount of the order within 10 days from the date receipt of this order, by Cash/DD/FDR to this office. Cash must directly remit to bank.
