- 2] The quotation should be addressed to the Addl. Executive Engineer EHV Projects Division, Kolhapur.
- 3] The supplier has to furnish GST, PAN No. in the offer.
- 4] **Work Period :** As mentioned in Schedule 'A'.
- 5] **Taxes:** The rates quoted shall be inclusive of GST & LWC & all other duties, which are payable by the contractor as per statutory regulations.
- 6] **Rates :** Rates should be firm and for the said destination inclusive of all taxes.
- 7] Income Tax & LWC shall be deducted from the bills at prevailing rates as per Income Tax Act, 1961 if applicable.

- 8] **Quantity** : The Quantity mentioned in the Schedule 'A' is tentative and subject to variation on either-wise. However, payment will be made for the material/Work actually received/Completed.
- 9] **Payment** : Payment will be made at Division Office, Kolhapur after completion of 100% work carried out by the contractor for all approved works executed as fixed by the Engineer.
