- 2) **TERMS OF PAYMENT**: 100% payment will be effected to you against M.B recording after Warrantee certificate, Advance stamp receipt etc subject to availability of funds.
- 3) **PAYMENTS**: The bills in original in triplicate should be submitted to this office for payment with necessary documents such as warrantee certificate etc.
- 4) **WARANTEE**: You have to furnish the warrantee of material for 12 months from the date of receipt against any manufacturing defect etc. the undertaking as such should be sent along with the bills.
