3. Quantity mentioned in the schedule is approximate & subject to variations.
4. Approximately estimated cost is limited upto Rs.47,911/- Including all.
5. All other general terms & conditions of MSETCL work contract are applicable to this SRM Enquiry.
6. EMD :- Rs.05,000/- (Rs. Five Thousand Only)
7. SRM Enquiry Fees :- Rs.105/- (Rs.100 + 5% GST).

## TECHNICAL QUALIFYING REQUIREMENTS :

Bidder should upload the following digitally scan copies of original documents/ certificates online under technical bid.

1. Proof regarding filing of annual Income Tax Return for last 02 assessment years.
2. Proof of PAN & GST Tax Registration Certificates.
3. Proof of registration of firm under Bombay shop & establishment act OR Copy of NOC from Local Grampanchayat.
4. Copy of the sample approval for the required Silica Gel to be supplied against the said SRM-Enquiry as approved by Ex.Engineer 400 KV R.S.(O&M) Dn. Karad OR Undertaking before supply.
5. Proof regarding submission of SRM Enquiry fee and EMD through online facility **OR** if any exemption is availed from payment of EMD on the basis of SSI/NSIC Certificate etc.

**Then obtain certificate from practicing Cost Accountant/Chartered Accountant. Stating that :**

- A. The Material/Service required against present tender are covered under said SSI/NSIC Certificate.
- B. Turnover/Manufacturing capacity have not exceeded the limit indicated in said SSI/NSIC Certificate as on date of submission of bid.

If required EMD is not paid or both of above certificates for exemption of EMD is not submitted then respective bid is straight away liable for rejection.

- The micro and small enterprises (only manufacturing and service enterprises) as defined in MSMED Act, 2006 are exempted from paying EMD and tender fees. The Udyog Aadhar Memorandum and Udyog Aadhar Registration Certificate submitted by said enterprises should indicate the same Material / Service as required against the tender floated.
- **The bidder has to pay EMD and tender fees in following cases:**
  - A. If the Micro/Small Enterprises Registration Certificate does not indicate the relevant classification code covering Material / Service and required against the tender floated.
  - B. If the investment in plant and machinery or equipment exceeds the threshold limit indicated in the MSMED act, 2006 (at present the threshold prescribed limit being for Micro upto Rs.25 Lakhs; Small – Rs.25 Lakhs to 5 Crs. as investment in plant and machinery and for Micro – upto Rs.10 Lakhs; Small – Rs.10 Lakhs to Rs.2 Crs. as investment in equipments)

In case of works contract, if the Micro and Small Enterprises submits that the enterprise shall supply all the materials of intended works contract, manufactured from its own unit, then it shall be eligible for exemption of payment of EMD & Tender Fees to MSETCL. However, an undertaking duly notarized from Micro and Small Enterprise to this effect is to be submitted along with bid.


- The works contractor except as stated above and tenders are excluded from the benefits of EMD and tender fees, hence shall be required to pay EMD or tender fees while participating for e-tender process at MSETCL.

- The registration certificate as submitted by Micro and Small enterprises shall be valid on the date of submission of bid and the validity of the same should be certified by the Chartered Accountant in practice.

**Note: - In case, the micro and small enterprises (who have been exempted from payment EMD / Tender fees) does not accept the tender being L1, then such micro and small enterprises shall be debarred form the bidding process for the all tender at MSETCL for next 2 years from the date of non-accepting of L1 bid.**

**Please Note :- If required EMD is not paid OR both of the above certificates for exemption of EMD is not submitted then respective bid is straight away liable for rejection as per Corporate Office guidelines.**

4. **SUPPLY OF MATERIAL :-** The supplied material should be strictly confirmed to our specification & confirming to IS Standard otherwise same will be rejected.
5. **DELIVERY :-** The delivery of the material should be **within 60 days** from the date of issue of actual order.
6. **TRANSPORTATION :-** The necessary transportation should be arranged by you upto 400 KV Karad.
7. **GST :-** The prevailing rates of the GST will be applicable & that will be binding on you.
