Subject: SRM E-enquiry for the Work of Supplying Water Tankers (5000Ltrs.) for water to switchyard equipment earthing on as and when required basis at 400kV RS Dhule S/S.

Sealed and super scribed quotations are invited for the above work as per enclosed schedule 'A'. You are requested to quote your lowest rate for the above work. The terms and conditions are as follows.

# General terms & conditions

- 1. Per trip rates quoted should include provision of Driver, Diesel required for all instructed trips, his salaries & allowances, Water Tanker maintenance, Taxes, and all other charges etc. No extra charges will be paid other than quoted rate by MSETCL.
- 2. Bidders should strictly follow norms & safety measures prescribed by RTO for Supplying Water Tankers for water services.
- 3. Your quotation should reach this office on or before 26.03.2020 upto 17:30hrs and same shall be opened on next day if possible.
- 4. The order is limited to the period of half year or till the order value exhausts, Limited amounting Rs. 200,000/- (including all taxes)
- 5. The work contract tax if applicable will be deducted from your Bill as per rule
- 6. The Company will not be responsible for any kind of accident or damages to the Water Tanker or its driver during the hired period. All the financial liabilities arising out of accident shall be borne by the owner of
- 7. The working hours will be normally from 07.00 Hrs to 19.00 Hrs or as and when required per directives of undersigned.
- 8. Any kind of Water Tanker breakdown should be attended by owner. No charges will be paid by Company during breakdown. Agency will have to provide alternate Water Tanker during breakdown at same rate.
- 9. According to financial act, income tax will be deducted from your bill& certificate to that will be issued to
- 10. The rate quoted should be firm & price variation will not be acceptable. Rate should be inclusive of all taxes & other incidental charges.
- 11. Water Tanker capacity should be at least 5000Ltr. & water shall be drawn till empty at 400KV RS
- 12. Driver should be managed by Water Tanker owner. He should have valid license to drive such type of Water Tanker and. Driver should not have any criminal record & NO FIR should be registered on him. Driver should not found with any type of alcoholic drunk during Working hours.
- 13. All the rules regarding registrations of Water Tanker, sales tax, GST tax & other Govt. taxes etc should be borned by Water Tanker owner.
- 14. If it is found that Water Tanker is not giving satisfactory service, the contract is liable for cancellation after giving 24 Hrs notice.

- 15. Security deposits: The You have to pay a security deposit of 5% of the order value for this work with MSETCL in the form of FDR/D.D./BG of any Nationalized/scheduled Bank in the name of 'Executive Engineer, 400KV R.S O&M Division, Dhule', payable at Dhule, valid for one year. The security Deposit to be submitted before starting of work. The security deposit will be refunded only after satisfactory completion of contract.
- 16. The validity of your work order will be for one complete year from the date of issue of order or Exhaust of Tendered amount from the date of engaging the Water Tanker whichever is earlier.
- 17. All terms and conditions as per Company's rules including those work in the M.S.E.T.Co.Ltd. booklet. "Tender and contract for works" are applicable in this case also. Not with standing stated herein, the Company's general terms and condition of contract shall be applicable to this contract also.
- 18. Undersigned reserves the right to accept any Tender or to reject/accept all the Tenders without assigning any reason.
- 19. Any dispute/differences arises, will be subjected to jurisdiction of Dhule court only
- 20. The Water Tanker owner if wants any clarification regarding working of Water Tanker or any terms condition, he should approach in writing to undersigned before quoting the rates.
- 21. After due date no clarification will be given and the decision of undersigned will be final and binding on all the Water Tanker owners quoting for said work.
- 22. The work shall be supervised by the Engineer, appointed by under signed and it should be carried out to the satisfaction of Engineer In charge. In case of any dispute, decision of undersigned shall be final and binding on the contractor.
- 23. Liquidated Damages / Loss due to theft: Any damage or loss to M. S. E T. Co. Ltd's property due to your employees/workers/driver's negligence during the course of contract shall be on contractor's part and same shall be recovered from the bill.
- 24. The M. S. E. T. Co. Ltd. shall not be responsible for injury or death of your employee during the course of contract. Contractor will have to provide safety equipment's to his employees. Contractor will be solely responsible for compensation or medical treatment etc. for all the liabilities arising out of such accident.
- 25. Bill payment will be paid to you by account payee cheque in reasonable time and as per the availability of funds after the satisfactory completion of work and as per measurement recorded in SAP-SES.
- 26. Bill will be paid on Actual full water tanker (5000Ltr.) quantity measurement & not on liters of water supply. M.S.E.T.Co. Ltd. reserves rights to add more terms during the contract period if found necessary.
- 27. The said Water Tanker should not be owned by Company's employee/his nearest relatives.
- 28. After due date no clarification will be given and the decision of undersigned will be final and binding on all the Water Tanker owners quoting for said work.
- 29. The completely filled tender offer will be accepted to this office on or before 14.08.2018 upto 17:30hrs and same will be opened on the next working day if possible.
- 30. The undersigned reserves the right to cancel the contract, after giving due notice to you, in the event of breach of contract in any respect or under delay in execution of work.
- 31. Penalty: in the event of service not provided /satisfactorily the contractor shall be liable to pay the penalty as 1/2% per day and maximum of 10% of total value of contract.
- 32. If the tenderer fails to provide the service on time, it will be treated as breach of contract & contract will be terminated & order will be cancelled and forfeiting the S.D.
- 33. You should have to execute the agreement on stamp paper of Rs.500/- at your own cost as per the provision of 'Mumbai Mudrank Adhiniyam 1958, Clause No. 34' with requisite stamp duty immediately after the payment of security deposit. The notary should be done of stamp duty

# **Instructions to Tenderer**

- 1. The tenderer duly filled in should be sent in a cover properly sealed and super scribed as shown below in person only to Executive Engineer 400KV RS Division, Dhule so as to reach not later than due date. The cover should be super scribed with name of work and Enquiry No.
- 2. The said Water Tanker should not be owned by MSETCL company employee/his nearest relatives.
- Driver should be managed by Water Tanker owner. He should have valid license to drive such type of Water Tanker & has experience for driving such type of Water Tanker.
- 4. Only one envelope for tender filled in & for all documents of Water Tanker such as :
  - a) Valid shop act & establishment registration/grampanchayat NOC as applicable.
    - b) Documents of Water Tanker such as RC/TC book, make, model, capacity of Water Tanker (Min.), RTO Water Tanker permit (if any), insurance, fitness certificate.

- c) PAN no. copy should be submitting.
- d) Proof regarding registration under GST or If not applicable then undertaking regarding that.
- e) Tenderer have similar type of experience of water Tanker services in MSETCL or MSEDCL will be preferred.
- 5. The successful bidder shall have to pay the prescribed security deposit amounting to 5% of total contract value.
- 6. Tender Fee: Rs.100/- will be the tender fees to be paid before or while submitting the quoted bid within due date.
- 7. The Maharashtra State Electricity Transmission Co. Ltd. or its officer who accepts the tender shall have the right to reject any or all the tenders in part or full and will not be bound to accept the lowest nor to assign any reason what-so-ever for such rejection/acceptance.
